Dear Chair Durbin, Ranking Member Grassley, and Committee Members:

On behalf of the following 60 interfaith organizations representing millions of people across the United States, we write in strong support of Nancy Abudu's nomination to the United States Court of Appeals for the Eleventh Circuit. Our organizations collectively represent a broad spectrum of people of faith, united by the theological belief that each person is created in the image of God, and that every person is worthy of dignity and respect. Ms. Abudu is an exceptionally well qualified nominee who has had a distinguished career working to defend and preserve the rights of many individuals, including some of our society's most at risk and marginalized people.

Ms. Abudu's professionalism, integrity, and deep experience have prepared her well to serve honorably as a judge on the Eleventh Circuit. Early in her career, Ms. Abudu worked as an associate in a large law firm and then as a staff attorney for the Eleventh Circuit. In that position, Ms. Abudu had many opportunities to work with judges and to observe the advocates who represented clients before the court. In 2005, Ms. Abudu made a career change that would enable her to use her education, energy, and talents to defend and protect the constitutional rights guaranteed to all Americans. That work, in positions of ever-increasing responsibility with the ACLU and now with SPLC, has focused on providing legal representation to many of those least able to represent themselves.

Among the many cases Ms. Abudu has litigated over the years are several in which she advocated on behalf of religious accommodation rights for people of faith. In one case, Ms. Abudu served as co-lead counsel representing a Collier County, Florida police officer who alleged that he had been subjected to religious discrimination during his employment with the sheriff's office, in violation of Title VII. This person, a Hasidic Jew, alleged that his supervisors would frequently make fun of his attire, routinely schedule him to work on Saturdays, and try to pressure him into eating pork and other prohibited foods — even though they were aware that his faith prohibited him from doing these things. Another case in which Ms. Abudu served as lead counsel involved Muslim prisoners incarcerated in the Miami Dade county jail who were being denied Halal meals. That case ended in a settlement in which the plaintiffs and other similarly situated individuals began receiving Halal means and secured additional accommodations during Ramadan.

Ms. Abudu has also represented veterans and others with disabilities, individuals experiencing homelessness, and people seeking to exercise the right to vote. Her extraordinary talents and leadership were recognized this year when Ms. Abudu was selected to serve as an advisor and mentor for Harvard Law School students considering jobs in public interest as a prestigious Wasserstein Fellow. She has also served as an international election observer in Albania, as a member of the American Bar Association's Standing Committee on Election Law, and the ABA's Working Group on Building Trust in the American Justice System.

Ms. Abudu's entire career has demonstrated a deep commitment to the highest ideals of justice and equality — and to the ethical treatment of every human being. She has always represented her clients zealously, as an ethical lawyer's oath requires, and with good judgment, excellence, and integrity. Given the array of issues considered by the Eleventh Circuit, including a range of religious liberty issues, Ms. Abudu's background and experience have prepared her well to serve with distinction on the court.

If confirmed, we are confident that Ms. Abudu will uphold her oath as a judge with equal dedication by applying the Constitution and laws of our country in a fair, open-minded, and impartial manner. We urge you to support Nancy Abudu's nomination to the United States Court of Appeals for the Eleventh Circuit.
