## Re: Letter of Support to Confirm Tana Lin, Nominee for the United States District Court for the Western District of Washington

Dear Chairman Durbin and Ranking Member Grassley:

The Asian Bar Association of Washington ("ABAW"), the Filipino Lawyers of Washington ("FLOW"), and the Vietnamese American Bar Association of Washington ("VABAW") write to strongly support the confirmation of Tana Lin to serve as District Court Judge for the United States District Court for the Western District of Washington.

If confirmed, Ms. Lin will be the first Asian American in the state of Washington to serve as an Article III judge. Thus, Ms. Lin's confirmation would be a monumental achievement for the AAPI community in Washington state. Asians make up the largest minority racial group in Washington, comprising 9.2 percent of the state's total population as of 2020. We believe it is imperative that the federal judiciary reflect the people the court serves.

Ms. Lin is an accomplished and experienced litigator, with a reputation in the legal community for exceptional legal acumen, work ethic, and integrity. Ms. Lin has had a wide and varied legal career, both in the private and public sectors, and her depth of experience will be a significant asset to the Western District of Washington.

Ms. Lin's personal story is particularly compelling. Ms. Lin immigrated to the United States from Taiwan when she was three years old, speaking only Mandarin at home before she enrolled in school. Ms. Lin worked at a K-Mart in high school while juggling school and extracurricular activities. Through tremendous hard work and determination, Ms. Lin earned the right to attend Cornell University and New York University School of Law, working multiple jobs during both college and law school. Ms. Lin has fought to overcome adversity and has achieved greatness in the law. She embodies a fortitude that we all should be proud of, and that we all should strive for.

Ms. Lin has been a member of ABAW since 2016, including past service as a volunteer with the Joint Asian Judicial Evaluations Committee, a committee that evaluates judges and candidates for judicial positions within the State of Washington and provides such evaluations for review by the Governor of the State of Washington and the general public. In addition, Ms. Lin has served as a mentor to many attorneys, volunteering her time to help train the next generation of lawyers. Ms. Lin's efforts have helped continue traditions of excellence and professionalism in the judiciary and in the practice of law.

ABAW, FLOW, and VABAW are extremely proud of Ms. Lin's historic nomination and urge the Senate to swiftly confirm Ms. Lin for District Court Judge for the Western District of Washington.
