During my more than a decade of service as a United States Magistrate Judge, I have issued over 750 opinions and thousands of orders. To the best of my knowledge, I have only been reversed or affirmed with significant criticism of my substantive or procedural rulings in the following cases.

Tecarlo B. v. Kijakazi, No. 7:20-cv-473, Dkt. 21 (W.D. Va. Nov. 29, 2021) (copy supplied), *R&R rejected*, 2022 WL 36166 (W.D. Va. Jan. 4, 2022) (Urbanski, J.). In this social security disability appeal, I recommended affirming the decision of the administrative law judge (ALJ) denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to adequately explain how he weighed the medical opinions in the record and that

his assessment of the plaintiff's residual functional capacity was not supported by substantial evidence.

Sam D. v. Saul, No. 6:19-cv-72, Dkt. 23 (W.D. Va. Feb. 10, 2021) (copy supplied), *R&R rejected*, 2021 WL 1167285 (W.D. Va. Mar. 26, 2021) (Moon, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to properly explain the weight he gave to the opinion of the plaintiff's treating doctor.

Redd v. Saul, No. 7:19-cv-672, Dkt. 22 (W.D. Va. Feb. 4, 2021) (copy supplied), *R&R rejected*, 2021 WL 1554888 (W.D. Va. Apr. 20, 2021) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to properly consider certain of the plaintiff's evidence.

Paul B. v. Kijakazi, No. 6:20-cv-78, Dkt. 18 (W.D. Va. Dec. 8, 2021) (copy supplied), *R&R rejected*, 2022 WL 989242 (W.D. Va. Mar. 31, 2022) (Moon, J). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to adequately explain how he assessed the treating physician opinion, did not provide a function-by-function analysis, and improperly discredited the plaintiff's subjective testimony.

Booker v. City of Lynchburg, No. 6:20-cv-11, 2020 WL 8513807 (W.D. Va. Nov. 12, 2020), *R&R adopted in part and rejected in part*, 2021 WL 519905 (W.D. Va. Feb. 11, 2021) (Moon, J). In this 42 U.S.C. § 1983 case, I recommended granting the plaintiff's motion for leave to file an amended complaint to allege *Monell* claims for excessive force based on an expressly adopted official policy, a longstanding practice or custom, ratification, and failure to train. The district court largely agreed with my recommendation, except that it concluded amending the complaint to assert *Monell* claims based on an expressly adopted official policy or ratification would be futile.

Dawn M. v. Kijakazi, No. 6:20-cv-36, Dkt. 22 (W.D. Va. Aug. 5, 2021) (copy supplied), *R&R rejected*, 2022 WL 989241 (W.D. Va. Mar. 31, 2022) (Moon. J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ did not properly assess the treating physician's opinion.

Jerry V. v. Saul, No. 7:19-cv-00238, Dkt. 17 (W.D. Va. Aug. 17, 2020) (copy supplied), *R&R rejected*, 2020 WL 6087953 (W.D. Va. Oct. 15, 2020) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected

that recommendation, finding that the ALJ had not properly evaluated the plaintiff's allegations.

Pamela C. v. Saul, No. 7:19-cv-72, Dkt. 24 (W.D. Va. Aug. 4, 2020) (copy supplied), *R&R rejected*, 2020 WL 6375167 (W.D. Va. Oct. 30, 2020) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ's assessment of the plaintiff's mental impairments was not supported by substantial evidence.

George C. o/b/o J.C. v. Saul, No. 7:19-cv-77, Dkt. 26 (W.D. Va. July 28, 2020) (copy supplied), *R&R rejected*, 2020 WL 5637965 (W.D. Va. Sept. 21, 2020) (Urbanski, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ did not adequately explain why she gave limited weight to the findings of the consultative examiners and failed to discuss certain objective test results.

Dwayne L.S. v. Saul, No. 7:18-cv-573, Dkt. 22 (W.D. Va. Feb. 26, 2020) (copy supplied), *R&R rejected*, 2020 WL 1539289 (W.D. Va. Mar. 31, 2020) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that certain of the plaintiff's evidence should have been but was not considered below.

Timothy S. v. Saul, No. 7:19-cv-29, Dkt. 20 (W.D. Va. Feb. 27, 2020) (copy supplied), *R&R rejected*, 2020 WL 1443200 (W.D. Va. Mar. 24, 2020) (Urbanski, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ's assessment of the plaintiff's mental health issues and residual functional capacity was not supported by substantial evidence.

Sharon B. v. Saul, No. 7:19-cv-59, Dkt. 20 (W.D. Va. Feb. 24, 2020) (copy supplied), *R&R rejected*, 2020 WL 1665316 (W.D. Va. Apr. 3, 2020) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to adequately explain why he did not adopt the medical opinion regarding the plaintiff's residual functional capacity issued by the doctor who performed a consultative physical exam.

Linda H. o/b/o K.S. v. Saul, No. 7:18-cv-632, Dkt. 21 (W.D. Va. Feb. 6, 2020) (copy supplied), *R&R rejected*, 2020 WL 1450573 (W.D. Va. Mar. 20, 2020) (Urbanski, J). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district

court rejected that recommendation, finding that the ALJ failed to properly evaluate certain of the plaintiff's limitations.

Bradley H. v. Comm'r, No. 7:18-cv-380, Dkt. 20 (W.D. Va. Feb. 6, 2020) (copy supplied), *R&R rejected*, 2020 WL 1289538 (W.D. Va. Mar. 18, 2020) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to adequately address whether the plaintiff would need special assistance or supervision to work.

Easter v. Contech Constr. Prod., Inc., No. 7:14-cv-00568, Dkt. 117 (W.D. Va. Sept. 5, 2019) (copy supplied), *R&R adopted in part and rejected in part*, 2019 WL 4781880 (W.D. Va. Sept. 30, 2019) (Dillon, J.). I ruled that a business was not a successor in interest to a settlement agreement, but that if it were, the business could be held liable for the amounts owed. The district court agreed with my determination that the business was not a successor in interest, but found it unnecessary to rule on, and thus did not adopt, my other conclusion.

Billy H. v. Saul, No. 7:18-cv-171, Dkt. 25 (W.D. Va. Aug. 15, 2019) (copy supplied), *R&R rejected*, 2019 WL 4783116 (W.D. Va. Sept. 30, 2019) (Urbanski, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to give adequate weight to the opinions of the consultative medical examiners and that its ruling on residual functional capacity was not supported by substantial evidence.

Carlos E. v. Saul, No. 7:18-cv-337, 2019 WL 4454513 (W.D. Va. June 25, 2019), *R&R rejected*, 2019 WL 4455991 (W.D. Va. Sept. 17, 2019) (Urbanski, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to adequately explain how he assessed the plaintiff's subjective complaints and residual functional capacity.

Amy R. v. Saul, No. 7:18-cv-272, Dkt. 23 (W.D. Va. May 24, 2019) (copy supplied), *R&R rejected*, 2019 WL 4262514 (W.D. Va. Sept. 9, 2019) (Urbanski, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that certain of the plaintiff's evidence should have but was not considered below.

Supinger v. Virginia, No. 6:15-cv-17, 2019 WL 1450530 (W.D. Va. Mar. 4, 2019), *R&R adopted as modified*, 2019 WL 1446988 (W.D. Va. Mar. 31, 2019) (Moon, J.). In this employment action, I recommended awarding the plaintiff attorneys' fees and costs. In calculating the applicable lodestar, I declined to consider the results in a companion case because it had been appealed to the Fourth Circuit. The district court adopted my recommendation, except that it

reduced my lodestar figure by 10% based on the results in the companion case, the appeal for which had by then been resolved.

Teresa W. v. Berryhill, No. 7:17-cv-430, Dkt. 19 (W.D. Va. Feb. 20, 2019) (copy supplied), *R&R rejected*, 2019 WL 1294649 (W.D. Va. Mar. 20, 2019) (Urbanski, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to properly consider the opinion of the plaintiff's treating physician.

Zen42, LLC v. Wash. & Lee Univ., No. 6:17-cv-53, 2018 WL 10593818 (W.D. Va. Aug. 31, 2018), R&R adopted in part, 2018 WL 4625627 (W.D. Va. Sept. 26, 2018) (Moon, J.). This breach of contract case was referred to me for a report and recommendation on the amount of attorneys' fees, after the plaintiff accepted an offer of judgment, exclusive of such fees. I determined a reasonable hourly rate, reduced the hours billed both pre-litigation and post-litigation by 65%, and awarded the costs and expenses sought, except for reducing the amount claimed for experts. The district court adopted essentially all of my recommendation, except that it allowed the plaintiff to recover for 53 hours billed for pre-litigation work by plaintiff's counsel that I had excluded.

Vernon T. v. Berryhill, No. 7:17-cv-96, 2018 WL 4441787 (W.D. Va. Aug. 20, 2018), *R&R rejected*, 2018 WL 4431414 (W.D. Va. Sept. 17, 2018) (Urbanski, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that certain of the plaintiff's evidence should have but was not considered below.

Tameisha M. o/b/o T.M. v. Berryhill, No. 7:17-cv-127, Dkt. 19 (W.D. Va. Aug. 8, 2018) (copy supplied), *R&R rejected*, 340 F. Supp. 3d 573 (W.D. Va. 2018) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ had failed to adequately explain his consideration of a questionnaire completed by the plaintiff's teacher showing limitations on attendance and completing tasks.

Littles v. Berryhill, No. 6:17-cv-43, Dkt. 19 (W.D. Va. June 12, 2018) (copy supplied), *R&R rejected*, 2018 U.S. Dist. LEXIS 162214 (W.D. Va. Sept. 21, 2018) (Moon, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that new evidence submitted by the plaintiff created a reasonable possibility that the outcome would have been different had it been presented to the ALJ.

Fears v. Berryhill, No. 6:16-cv-55, 2018 WL 1548907 (W.D. Va. Feb. 26, 2018), *R&R rejected*, 2018 WL 1547365 (W.D. Va. Mar. 29, 2018) (Moon, J). In this

social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to properly consider the plaintiff's mental impairments in determining residual functional capacity.

Basham v. Jenks, No. 7:17-cv-202, 2018 WL 2172558 (W.D. Va. Jan. 3, 2018), R&R adopted in part, 2018 WL 2172786 (W.D. Va. May 10, 2018) (Urbanski, J.). In this breach of contract action, I recommended granting the defendant's motion for judgment on the pleadings and denying the plaintiff's motion for leave to amend as futile. The district court agreed with my recommended disposition and much of my analysis, but disagreed with my discussion of Virginia contribution law.

Altizer v. Colvin, No. 7:14-cv-432, Dkt. 19 (W.D. Va. Jan. 25, 2016) (copy supplied), *R&R rejected*, 2016 WL 1273493 (W.D. Va. Mar. 29, 2016) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding new evidence from the plaintiff's medical providers regarding his back treatment and diagnoses created a reasonable possibility that the outcome would have been different.

Perdue v. Colvin, No. 7:14-cv-173, Dkt. 24 (W.D. Va. Aug. 12, 2015) (copy supplied), *R&R rejected*, 2015 WL 5771813 (W.D. Va. Sept. 30, 2015) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ had not adequately accounted for the plaintiff's limitations in concentration, persistence, and pace in his hypothetical question to the vocational expert.

McGuire v. Colvin, No. 7:14-cv-258, Dkt. 22 (W.D. Va. Aug. 10, 2015) (copy supplied), *R&R rejected*, 131 F. Supp. 3d 559 (W.D. Va. 2015) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to provide a hypothetical question to the vocational expert that included the work-related limitations identified by the consultative psychologist and failed to adequately consider the plaintiff's subjective complaints of pain.

Harmon v. Colvin, No. 7:14-cv-303, Dkt. 17 (W.D. Va. Aug. 7, 2015) (copy supplied), *R&R rejected*, 2015 WL 5708934 (W.D. Va. Sept. 28, 2015) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that certain of the plaintiff's evidence should have been but was not considered below.

Rountree v. Clark, No. 7:11-cv-572, 2014 WL 4923964 (W.D. Va. Mar. 24, 2014), *R&R adopted in part*, 2014 WL 4923163 (W.D. Va. Sept. 30, 2014) (Conrad, J.). In this 42 U.S.C. § 1983 action, I recommended dismissing the plaintiff's complaint for failure to exhaust administrative remedies. The district court agreed that many of the plaintiff's claims should be dismissed for failure to exhaust, but concluded that certain of the other claims had been exhausted.

Gemaehlich v. Johnson, No. 7:12-cv-263, Dkt. 128 (W.D. Va. Sept. 12, 2013) (copy supplied), *rev'd*, Dkt. 138 (W.D. Va. Sept. 27, 2013) (Wilson, J.) (copy supplied). I granted the defendants' motion to compel the plaintiff to respond to an interrogatory about the dates he first consulted and hired an attorney, finding it potentially relevant and not privileged. The district court reversed, concluding that the burden of the proposed discovery, specifically the potential that it may lead to information protected by privilege, outweighed the benefit.

Robinson v. Colvin, No. 7:12-cv-272, Dkt. 21 (W.D. Va. Aug. 20, 2013) (copy supplied), *R&R rejected*, 2014 WL 1276507 (W.D. Va. Mar. 27, 2014) (Urbanski, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ had not adequately considered whether the plaintiff satisfied the relevant standard.

Blount v. Tate, No. 7:11-cv-91, 2012 WL 4341083 (W.D. Va. Aug. 24, 2012), *R&R adopted in part*, 2012 WL 434744 (W.D. Va. Sept. 21, 2012) (Conrad, J.). This 42 U.S.C. § 1983 excessive force case was referred to me on the defendants' motion for summary judgment. I recommended granting the motion as to all five defendants. The district court largely adopted my recommendation, except that it allowed the case to proceed to trial against two of the defendants.

Henley v. Comm'r., No. 7:11-cv-480, Dkt. 16 (W.D. Va. Oct. 31, 2012) (copy supplied), *R&R rejected*, Dkt. 18 (W.D. Va. Nov. 29, 2012) (Wilson, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ failed to account for certain of the plaintiff's functional limitations.

Wills v. Astrue, No. 6:11-cv-25, Dkt. 17 (W.D. Va. July 25, 2012) (copy supplied), *R&R rejected*, 2012 WL 4057238 (W.D. Va. Sept. 14, 2012) (Conrad, J.). In this social security disability appeal, I recommended affirming the decision of the ALJ denying disability benefits to the plaintiff. The district court rejected that recommendation, finding that the ALJ had not provided a proper hypothetical question to the vocational expert.

The United States District Court for the Western District of Virginia maintains an automatic conflict checking system. I provide the clerk's office a list of individuals and entities in whose cases I would recuse, and I have regularly updated that list. When a conflict is identified, the clerk's office reassigns the matter to another judge. I have never recused myself *sua sponte* except pursuant to the procedure just described, and a litigant or attorney has sought my recusal just once. Specifically, a third-party defendant in *Collier v. Land & Sea Restaurant Co., LLC*, No. 7:13-cv-104 (W.D. Va.), moved for my recusal on the

ground that my former firm represented the lead defendant. I denied the motion because the district court referred the case to me more than two years after I joined the bench, and legal ethics opinions from the Administrative Office of the United States Courts made clear that I only needed to recuse from cases involving my former firm for my first two years as a judge. The third-party defendant did not appeal that ruling.

This personal injury action against the defendant driver and his employer involved an accident in which the defendants' food delivery truck pulled out of a restaurant parking lot and collided with the plaintiff's vehicle while he was passing several cars stopped in a line of traffic waiting for a stoplight. The ambiguity of the road markings created an issue of whether the plaintiff was contributorily negligent for passing at an intersection or driving two abreast in a single lane. Following a trial, the jury ruled for the defendants, and the plaintiff appealed. The Virginia Supreme Court reversed, holding that the restaurant parking lot was not a highway under Virginia law and therefore the instruction that the accident occurred at an intersection of highways was error. As a United States Magistrate Judge, I am not permitted to represent clients in any capacity, but I routinely seek to serve the community in other ways.

For instance, since 2011, I have presided over the Western District of Virginia's veterans treatment court. Generally, the participants are veterans charged with misdemeanors, who have a history of substance abuse and/or a mental illness. As the court's presiding judge, I coordinate with a team of probation, medical, and other personnel that works together to help the veterans succeed by providing treatment and support. When a veteran graduates from the program, the charges are typically dismissed.

I also serve as one of three judges responsible for the administration of the Western District of Virginia's drug treatment court. Established in 2019, the court's participants are typically individuals charged with a violation of supervised release, who have a history of substance abuse and/or mental illness. As a presiding judge for the court, I attend meetings with the treatment team and follow up with the participants to manage compliance with the program's conditions. Upon successful completion of the program, the supervised release violation charges are typically dismissed.

In addition, I chair the Western District of Virginia Criminal Justice Act (CJA) Committee, which is responsible for selecting and recommending attorneys appointed to represent indigent defendants in criminal matters. This committee also works to ensure, consistent with the CJA, that the appointed lawyers provide a constitutionally adequate defense. In private practice, I likewise sought to contribute to the community in various ways. For example, I was deeply involved in work with the Virginia State Bar, including serving as President of the Bar's Young Lawyers Conference. In that capacity, I oversaw the activation of the Bar's disaster legal assistance plan to provide pro bono legal services to members of our community affected by a hurricane. Under my leadership, the Conference also sought to provide a wide range of programs to serve new and young lawyers transitioning to law practice. Finally, I served on the boards of Apple Ridge Farm, which provides wilderness educational experiences for underprivileged youth, and Valley Beautiful, which sponsors beautification projects in the Roanoke Valley.
