Dear Senate Judiciary Committee, Chairman Durbin, and Ranking Member Graham,

I am pleased to write this letter in my capacity as the President of the Korean American Bar Association of Southern California ("KABA SoCal") in support of the Honorable Anne Hwang, who has been nominated by President Joseph R. Biden to serve as a federal judge in the Central District of California. KABA SoCal is a key voice for Korean American lawyers as well as the Korean American community and is the largest Korean legal organization outside of Korea. We are proud to represent the Korean American legal community in the greater Southern California region.

The nomination of Judge Hwang is of great significance to the Korean American legal community. With over 200,000 residents of Korean descent, Los Angeles County is home to the largest population of Koreans in America. According to the American Community Survey's "Demographic and Housing Estimates" of 2022, more than 330,000 people of Korean heritage reside in the Central District of California, which includes Los Angeles, Orange, Riverside, San Bernardino, San Luis Obispo, Santa Barbara, and Ventura counties. Despite these statistics, the Central District of California has never had a Korean American serve as a federal district judge. If Judge Hwang is confirmed, she would be the first Korean American to have this honor.
