From 2021 to the present, I have served as the General Counsel of the Office of the Director of National Intelligence (ODNI). In this role, I provide advice and counsel to the Director of National Intelligence and other senior ODNI leaders on the full range of legal issues facing the agency, including issues involving intelligence law, employment matters, administrative matters, and budgetary and fiscal issues. As necessary, I also integrate and coordinate Intelligence Community (IC) legal views on issues that affect multiple IC elements.

From 2017 to 2021, I was a partner at Sidley Austin. In this role, my practice primarily focused on providing advice and counsel to clients on privacy and cybersecurity matters, including data breach response, compliance with relevant privacy laws, and other matters involving the governance of emerging technologies.

From 2013 to 2017, I was the Deputy National Security Council (NSC) Legal Adviser and then the NSC Legal Adviser. In this role, I provided

advice and counsel to the President, National Security Advisor, Homeland Security Advisor, and other senior White House and NSC officials on the full range of matters before the NSC, to include matters involving the use of military force, intelligence, foreign affairs, cybersecurity, and relevant administrative matters. I also supported and then chaired the interagency lawyers group responsible for coordinating legal views on national security issues.

In 2012, I was an attorney-adviser in the Department of Justice's Office of Legal Counsel (OLC). In this position, I participated in multiple aspects of the Office's work, including review of pending legislation and proposed Executive Orders and counseling officials from the Department of Justice and other Executive Branch entities on a range of issues. My work at OLC focused on national security, but also touched on a number of other areas, to include administrative matters and issues of statutory interpretation.

From 2010 to 2012, I was Special Counsel to the General Counsel of the Department of Defense. In this role, I provided advice and counsel to the General Counsel on a range of issues, including the use of military force, personnel matters, and other key issues affecting the Department.

From 2008 to 2009, I was an attorney on the Appellate Staff of the Department of Justice's Civil Division. In this role, I litigated civil matters before the U.S. Courts of Appeals, primarily concerning claims against the United States or issues of administrative law or statutory interpretation.

As a partner of Sidley Austin LLP from 2017 to 2021, my clients consisted primarily of corporations and other business entities and institutions, and I specialized in privacy and cybersecurity. As indicated in my response to Question 23, I also performed *pro bono* work.

All of my other roles were in the federal government, such that my only client in those roles was the United States. During my time at the Office of the Director of National Intelligence (2021-present), the National Security Council (2013-2017), the Department of Justice's Office of Legal Counsel (2012), and the Department of Defense (2010), I generally specialized in national security law, although, as noted above, in many of the roles, my work touched on a number of other areas of practice. When I was on the Department of Justice's Civil Appellate staff (2008-2009), I focused on appellate litigation involving the federal government.

During my time as a national security lawyer at the Office of the Director of National Intelligence, the National Security Council, and the Department of Defense, and as an attorney-adviser at the Department of Justice's Office of Legal Counsel, the majority of my legal work did not directly involve litigation and I did not appear in court.

At Sidley Austin, my practice consisted largely of regulatory and advisory work, and, much like with the roles discussed in the last paragraph, the majority of this work did not directly involve litigation. I did appear before a court (e.g., by filing an appearance or submitting an *amicus* brief) a small handful of times, all I believe with respect to *pro bono* representations.

When I was an attorney on the Department of Justice's Civil Appellate staff from 2008 to 2009, my practice was almost exclusively focused on appellate litigation before the U.S. Courts of Appeals, as follows:

Management Reporting and Disclosure Act (LMDRA). The Secretary brought this civil enforcement action after investigating an administrative complaint brought by a union member who was a candidate for president of Local 234. The district court dismissed the complaint for lack of subject matter jurisdiction, however, on the grounds that the administrative complaint had not been timely filed. I provided recommendations to the Solicitor General on seeking review and was the principal drafter of the Government's brief, arguing that the district court erred in dismissing the complaint. Although I left the Department of Justice before the case was argued, the Third Circuit agreed with our position and reversed.

2. Abington Crest Nursing and Rehabilitation Center v. Sebelius 575 F.3d 717

I represented the United States in this case concerning skilled nursing facilities' challenge to the Secretary of the Department of Health and Human Services' decision to deny them certain bad debt costs. The facilities argued that the Secretary's decision violated both the Medicare statute and agency regulations. I presented oral argument for the Government, arguing that the Secretary's decision violated neither the statute nor the Department's regulations. The D.C. Circuit agreed with the Government's position and upheld the lower court.

The district court agreed with the claimant, and I provided recommendations to the Solicitor General on seeking review and then was the principal drafter of the Government's brief, which argued that the decision to reimburse only up the least costly alternative was a reasonable construction of the statute.
