Throughout his professional career, Attorney Ritz has dedicated his practice to the Office of the U.S. Attorney for the Western District of Tennessee. He has focused his practice on appellate work before the U.S. Court of Appeals for the Sixth Circuit for thirteen of his eighteen years with that office. Prior to serving as a federal prosecutor, Attorney Ritz clerked for the Honorable Julia Gibbons of the U.S. Court of Appeals for the Sixth Circuit.
