Dear Senators Graham and Durbin:

I am writing in enthusiastic support for the confirmation of Judge Karoline Mehalchick, currently the Chief Magistrate Judge in the Middle District of Pennsylvania, as a District Judge in that same District. I am currently the National President of the Federal Bar Association (the "FBA") and met Judge Mehalchick through the FBA approximately ten years ago. From the time that I met Judge Mehalchick, she has been an invaluable asset to the FBA and has demonstrated a remarkable work ethic, thoroughness, and impressive capacity to resolve complicated problems. Moreover, she has always done so only after considering all sides of the specific issue and while treating people with the utmost respect and compassion.

I have worked closely with Judge Mehalchick throughout my involvement in the |FBA while we were both serving in various different capacities. Most recently, Judge Mehalchick and I worked together to advance several important initiatives in her role as Chair of the Judiciary Division. She has the skills, temperament, and experience to be an asset wherever she serves.
