Dear Senators Durbin and Graham:

I am writing in support of Brandon Long's nomination for the position of United States Federal District Judge for the Eastern District of Louisiana. I formerly served in a number of positions at the Department of Justice including Acting Deputy Attorney General, Chief of Staff to the Attorney General, Deputy Assistant Attorney General in both the Civil and Criminal Divisions and as an Assistant U.S. Attorney in the Southern District of New York and the Northern District of Georgia. I also practiced as a white-collar criminal defense attorney for many years.

I met Brandon just after he graduated from law school when he joined King & Spalding as an associate. As a partner with this law firm, I supervised Brandon's work in a number of significant matters from mid-2005 through the spring 2009. He is a man of principle who throughout his career has demonstrated a commitment to the rule of law. I believe strongly that, as a federal judge, he will be objective

and will follow the law in an impartial manner. He has the courage to do what is right under the law.
