Dear Chairman Durbin and Ranking Member Graham,

I write to recommend Tiffany R. Johnson for the vacancy on the U.S. District Court for the Northern District of Georgia, that was created as a result of Judge Steve Jones taking senior status.

As U.S. Attorney for the Northern District of Georgia from 2017 to 2021, I worked closely with Ms. Johnson. She joined the U.S. Attorney's office, as an Assistant U.S. Attorney, after nearly five years as an associate with Parker, Hudson, Rainer & Dobbs in Atlanta, Georgia. Ms. Johnson initially joined our Civil Division, handling a split docket of civil rights investigations and defensive civil cases. Beginning in January 2020, she also worked on a number of criminal matters, with a focus on white-collar crime and public corruption. Her breadth of experience in private practice and the U.S. Attorney's office has prepared her to serve with distinction as a U.S. District Court Judge in the Northern District.
