Dear Director Comey:

As I informed you in my February 26, 2015 letter, the Justice Department's Office of the Inspector General (OIG) submitted three reports last month pursuant to Section 218 of the 2015 Department of Justice Appropriations Act, each noting a failure of the Federal Bureau of Investigation (FBI) to provide the OIG with timely access to records, as required by law. On March 4, 2015, the OIG submitted a *fourth* Section 218 report. According to this report, the FBI failed to provide the OIG with timely access to records sought in connection with the OIG's review of the FBI's security clearance adjudication process.²

As explained in my previous letter, conducting lengthy internal reviews or seeking permission from senior officials before granting access to records unnecessarily delays the work of the OIG and conflicts with the statutory right of access guaranteed to that office. It also circumvents our oversight authority, which the law explicitly reserves for Congress through the notice requirement.³ Inaction or delay in response to a document request allows the Department's leadership to indefinitely prevent a review sought by the OIG, without having to report to Congress as the law requires.⁴

Moreover, Section 218 plainly contemplates that OIG shall have access "to *all* records, documents, and other materials," subject to the sole limitation of Section 6(a) of the IG Act. Section 6(a) does not limit the OIG's access to the categories of records the FBI has identified. Accordingly, despite my February 26, 2015 letter alerting you to this problem, the FBI appears to be engaging in a continuing pattern of violating the restriction on appropriations in Section 218.

Thus, please include in your answers to the questions in my February 26th letter information related to this latest Section 218 notice in addition to the three previous notices.
