Court of Appeals and U.S. Court of Appeals for the District of Columbia Circuit. I was proud to support her nomination by President Biden as Associate Judge on the District of Columbia Court of Appeals in 2021. She has also been a member of Georgetown Law's Supreme Court Institute since 2010.
