Dear Senators Durbin and Graham:

The undersigned, all former Assistant United States Attorneys for the District of Maine, write in support of Stacey D. Neumann of Scarborough, Maine, a nominee for appointment as a United States District Judge for the District of Maine. During her tenure as a federal prosecutor for our district, and subsequently as a private practitioner, Ms. Neumann has distinguished herself by virtue of a keen legal mind, tireless work ethic, and balanced and measured professional demeanor. For those of us familiar with her skills and collegiality, her appointment to the federal bench is a natural progression of her legal career and we have confidence that her confirmation by the United States Senate would be well received by the members of our federal bar and the public.

Ms. Neumann's academic credentials speak for themselves. Following her graduation from Cornell Law School, *magna cum laude* and *Order of the Coif*, she held two judicial clerkships, first with the Vermont Supreme Court and then with the Honorable Peter W. Hall of the United States Court of Appeals for the Second Circuit who had just recently been appointed to that bench by President Bush. Equipped with this fulsome academic exposure to the law, she served as an Assistant Public Defender in Vermont where she nurtured a love of the courtroom and a style of advocacy that emphasized preparedness, focused strategies, and fact-based decision making, attributes that her colleagues would come to greatly admire and now attest to.

During her subsequent years of service as an Assistant United States Attorney for the District of Maine, Ms. Neumann investigated and tried all manner of federal criminal matters, including fraud, firearms, drug trafficking, immigration, child pornography, and child exploitation cases. In recognition of her particular skills in dealing with the particularly sensitive and difficult genre of child abuse cases, Ms. Neumann was named the Office's *Project Safe Childhood* program coordinator. Herself a mother of four, Stacey Neumann was exceptionally effective in navigating that field of federal law and in the process endeared herself to her law enforcement colleagues, witnesses, victims and their families, the bench, and the bar.

Since leaving federal service and over the decade that followed, Ms. Neumann has become a valued and highly respected member of our private bar. In addition to her criminal law expertise, as a private practitioner she has expanded her expertise to include multiple areas of civil law and, not surprisingly, is in great demand from her colleagues as both a mentor and collaborator. She has been recognized by the United States District Court for her service to the cause of indigent defense by her appointment to its Criminal Law Committee and its Criminal Justice Act Panel Selection Committee. Beyond the courthouse, her contributions to our bar and public service have been impressive: election to the Maine State Bar Association's Board of Governors, a Director of the Maine Association of Criminal Defense Lawyers, and by gubernatorial appointment, a Commissioner on Maine's Commission on Governmental Ethics and Election Practices.
