#### 6. Mrs. J. v. Portland Public Schools, 2:15-cv-00084-DBH

I served as lead counsel in this matter in which our clients were seeking redress for their minor child under the Individuals with Disabilities Education Act (IDEA), alleging the public school had failed to provide their daughter a fair and appropriate education pursuant to federal and state law. 10. Unted States v. Infante, 2:10-cr-00123-DBH (D. Me.) (Hornby, J.)

I am active in numerous groups and committees in aid of the courts and the judicial system. In 2022, the United States Sentencing Commission appointed me to serve on the United States Sentencing Commission's Practitioners Advisory Group. The Practitioners Advisory Group meets regularly with the Commission to provide its views on the Commission's activities and work, particularly regarding proposed priorities and amendments to the Sentencing Guidelines. We research, draft, and submit proposed public comments to the Commission on which our designee testifies before the Commission.

Since 2013, I have been a member of the Criminal Justice Act panel as an attorney committed to taking court-appointed cases for defendants who qualify as indigent under the Act. Moreover, after having been asked by the court, I am a part of the selection committee that advises the district court on attorney applicants to include on the panel. This Committee raises, discusses, and works to resolve issues that arise in the federal criminal justice system within the District of Maine.
