His court-appointed habeas counsel withdrew and I was appointed by Judge Hoffman as replacement counsel in June 2016. Approximately one week after I was appointed, Mr. Berget decided to withdraw his habeas action and end his appeals. In the first week I was involved in the case, however, I discovered information in the file suggesting that Mr. Berget may have been intellectually disabled. Because the

Judge Hoffman ultimately determined Mr. Berget was not intellectually disabled. Mr. Berget did not wish to appeal. A law firm that was not counsel of record filed emergency appeals attempting to halt the execution with both the South Dakota Supreme Court and United States Supreme Court, both of which refused to halt the execution. I perform approximately 100 hours of pro bono legal work each year. My cases have varied. In the last two years, I have represented a number of individuals pro bono who received Pandemic Unemployment Assistance (PUA) benefits under the CARES Act during the pandemic only to be told several months or a year later that they must repay all of this money to the State of South Dakota. This work involves briefing, contested administrative hearings, and appeals to Circuit Court and potentially the South Dakota Supreme Court. For example, I recently prevailed in one of these cases before the South Dakota Supreme Court in Bracken v. South Dakota Department of Labor and Regulation, Reemployment Assistance Division, 2023 SD 22. In Bracken, the claimant was a selfemployed owner of a bed and breakfast who received PUA benefits. Several months after the benefits ceased, the claimant was ordered to repay them because the South Dakota Department of Labor claimed it had erroneously given her the benefits in the first place. Notably, the claimant was without fault in receiving the benefits and there was no allegation of fraud. The legal dispute centered around whether she was entitled to receive benefits under the CARES Act as a self-employed individual and the proper legal standard for paying such benefits. The South Dakota Supreme Court ruled the claimant properly received PUA benefits and did not need to repay them.

I have also recently taken on immigration cases pro bono for unaccompanied minors from Central America seeking Special Immigrant Juvenile Status under the federal immigration code. I also have taken on one pro bono asylum case for a woman from Central America. This work involves research, fact gathering, and briefing.

In the past I have taken on pro bono family law cases through South Dakota's legal aid organizations. In addition, I have taken on pro bono cases in misdemeanor criminal matters as well.

I have also been involved in serving on boards for non-profit organizations in Sioux Falls, South Dakota. Specifically, I served from 2008 through 2020 on boards for The Banquet feeding ministry in Sioux Falls. The Banquet serves food to the poor and underprivileged and is entirely funded by donations from our community. Since 2020 I have served on the board for Promising Futures, a non-profit organization dedicated to helping public school students in Sioux Falls living at or below the poverty line. Promising Futures is particularly focused on creating interest in reading for grade school students through its "Book a Month" club, which gives grade school students a book each month they can keep to read and also to start their own personal library. In addition, Promising Futures also funds and sponsors field trips for students to a number of locations, including museums, concerts, college campuses, trade schools, and athletic events.

On January 9, 2023, I spoke with Mr. Randy Seiler, the Chair of the South Dakota Democratic Party, about my interest in applying for the position of United States District Judge for the District of South Dakota. My understanding is Mr. Seiler forwarded my resume to the White House's representatives to review. On March 16, 2023, I was interviewed by attorneys from the White House Counsel's Office. Since March 16, 2023, I have been in contact with officials from the Office of Legal Policy at the Department of Justice. In addition, I have spoken briefly with representatives from the offices of Senators Thune and Rounds. I also met with Senator Rounds on June 28, 2023, and Senator Thune on July 31, 2023. On February 7, 2024, the President announced his intent to nominate me.
