The South Asian Bar Association of North America ("SABA North America"), the umbrella organization for 31 local chapters across the United States and Canada, writes in enthusiastic support of the historic nomination of Sharad Desai to serve as a United States District Judge for the District of Arizona. Mr. Desai's breadth of experience, commitment to justice and fairness, and diverse perspective unequivocally qualify him to be a district court judge.

SABA North America represents the rapidly growing South Asian legal community across North America. The organization promotes the professional growth and advancement of attorneys of South Asian descent and strives to protect the rights and liberties of the South Asian community. In light of its mission and vision, SABA North America recognizes a critical need for greater participation by South Asian-Americans in the federal judiciary. Through the appointment of Mr. Desai as well as other highly qualified South Asians to federal courts nationwide, we expect that significant progress towards fulfilling that need will be achieved.

Mr. Desai's legal experience underscores his qualifications to be a district court judge. He has 17 years of experience in both federal and state courts, first serving as a law clerk to Judge Rebecca White Berch with the Arizona Supreme Court, then as a civil litigator at Osborn Maledon, P.A. and Litigation Counsel at Honeywell International Inc. Over the course of his career, Mr. Desai's work has spanned a wide subject-matter spectrum, from products liability and commercial cases to civil rights cases and lawyer ethics cases. He has worked at both the trial and appellate levels and represented single parties as well as certified classes. Through these experiences, Mr. Desai has shown that he has critical skills required of a U.S. District Court Judge, namely the ability to engage in high level legal analysis, writing, and oral communications. His extensive trial experience makes him an ideal candidate for the federal judiciary, and the district court.

Mr. Desai's work is a testament to his commitment to promoting justice and fairness. Most notably, Mr. Desai served as *pro bono* counsel on a class action lawsuit brought

Mr. Desai has also been a committed supporter of his community and profession.
