4 (a) FINDINGS.—Congress makes the following find-

5 ings:

6 (1) U.S. Customs and Border Protection (re7 ferred to in this subsection as "CBP") is charged
8 with protecting the borders of the United States and
9 facilitating travel and trade.

1	(2) The Southern border of the United States
2	is experiencing unprecedented numbers of vulnerable
3	individuals attempting to enter the country.
4	(3) In June 2019, 104,344 individuals were ap-
5	prehended at the Southern border, which is an in-
6	crease of more than 140 percent, as compared to
7	June 2018.
8	(4) As of June 2019, the number of individuals
9	apprehended or determined to be inadmissible by
10	CBP at the Southern border in fiscal year 2019 is
11	780,638, already surpassing the fiscal year 2014
12	total of 569,287, which was the highest such number
13	in the preceding 5 years.
14	(5) The Homeland Security Advisory Council
15	expects Southwest border migration numbers to ap-
16	proach or exceed 1,000,000 individuals in fiscal year
17	2019 unless immediate action is taken.
18	(6) Historically, the majority of individuals ar-
19	riving at the Southern border have been single adult
20	males from Mexico, but by May 2019, 72 percent of
21	all border enforcement actions were associated with
22	unaccompanied children and family units.
23	(7) Due to the constant and increasing flow of
24	migrants crossing the Southern border between
25	ports of entry, financial and human resources are

1	being diverted from the security and law enforce-
2	ment duties of CBP, resulting in—
3	(A) fewer seizures of narcotics and illicit
4	currency; and
5	(B) increased wait times at ports of entry,
6	leading to warnings of possible produce short-
7	ages and interruptions in supply chains.
8	(8) More than 40 percent of CBP resources are
9	currently being absorbed by the humanitarian crisis
10	at the Southern border.
11	(9) The final emergency interim report pub-
12	lished by the Homeland Security Advisory Council
13	on April 16, 2019, notes that a substantial number
14	of individuals who are apprehended by CBP require
15	significant personal and medical care that exceeds
16	the ability and capacity of CBP, despite creative and
17	humane attempts by CBP to care for such individ-
18	uals in CBP custody.
19	(10) CBP officers and personnel have raised
20	concerns that overcrowding poses immediate risks
21	to—
22	(A) the health and safety of the migrants;
23	and
24	(B) CBP officers;

1	(11) CBP officers are experiencing both phys-
2	ical illness and severe mental and emotional distress
3	as a result of the crisis at the Southern border.
4	(12) In May 2019, the Commissioner of CBP
5	requested an additional $$2,100,000$ for the Em-
6	ployee Assistance Program of CBP in order to offer
7	additional counseling services to CBP officers and
8	personnel to respond to "unanticipated critical inci-
9	dents and other emerging crises, such as the unex-
10	pected response required for migrant caravans, em-
11	ployee suicides, and the need for a financial wellness
12	program".
13	(13) In the face of the most difficult cir-
14	cumstances, CBP officers and personnel continue—
15	(A) to work undaunted to protect the
16	Southern border; and
17	(B) to care for the migrants in CBP cus-
18	tody.
19	(b) SENSE OF CONGRESS.—It is the sense of Con-
20	gress that—
21	(1) the men and women of U.S. Customs and
22	Border Protection, including Border Patrol per-
23	sonnel, Office of Field Operations personnel, Air and
24	Marine Operations personnel, Office of Trade per-
25	sonnel, and all support personnel and their allies

1	should be commended for their continued honorable
2	service during the challenging humanitarian crisis at
3	the Southern border; and
4	(2) Congress will continue to support U.S. Cus-
5	toms and Border Protection officers and their ef-
6	forts to manage the increasing flow of migrants at-
7	tempting to enter the United States.
