Dear President Biden and Judge Mueller:

On behalf of the Wiley W. Manuel Bar Association (Wiley Manuel) and its Judicial Nomination Evaluation Committee for the County of Sacramento, we write this letter to support the application of Judge Dena Coggins for appointment and confirmation to the Eastern District of California. Wiley Manuel, through its judicial appointments committee, was asked to review the qualifications of Judge Coggins and provide a recommendation for appointment. We are pleased to advise that we find Judge Coggins to be an extremely well qualified candidate for the position of Federal Judge. Indeed, <u>Judge Coggins represents the very best among us</u>.

Wiley Manuel is the African American bar association of Sacramento County. Founded in 1977, its mission is to address the concerns of the black community and support the black lawyers and law students in the Sacramento region. Wiley Manuel's members play a vital role in the Sacramento legal community, and beyond. As Chair of the Judicial Nomination Evaluation Committee and as President-Elect of this esteemed bar association, I am grateful to have the opportunity to write this letter of support for Judge Coggins.

Judge Coggins has distinguished herself as a judicial officer, public servant, attorney, and mentor throughout her legal career. I first met her when I appeared before her when she was an administrative law judge. She presided over a 10-day trial involving multiple expert witnesses. In that case, I represented a school district in its effort to terminate the employment of a high school teacher who had made romantic solicitations via Instagram to his current and former students. The teacher mounted a novel defense. He argued that his conduct was on account of a mental disability that rendered him temporarily insane and that he had since found effective treatment for the disorder. Therefore, terminating his employment was tantamount to disability discrimination. The

teacher's argument benefitted from some legal and factual support. The trial also occurred during the middle of the COVID-19 pandemic, which produced additional logistical issues Judge Coggins had to manage. Throughout the trial Judge Coggins was a consummate professional. She was unbiased in her rulings and she put the witnesses (many of whom were victimized teenaged girls) at ease. In fact, this was my first trial, and she made the experience for me both valuable and smooth. On some issues she ruled against us, and on other issues she ruled for us. All her rulings were the correct decisions. I left that trial with the newfound desire to become a trial attorney and I have made career decisions to accomplish this goal. I owe this to Judge Coggins.

Judge Coggin's nearly 14-year legal career has taken her to top-tier law firms, the California Governor's Office, the California Office of Administrative Hearings, the California Victim Compensation Board, and the Superior Court of California. Her broad experience will provide her with the depth and range essential to inform the judgment of a federal judicial officer to make decisions that reinforce respect for the rule of law and the judicial system. Judge Coggins is eminently qualified for the federal bench. But more than her qualifications, who she is as a person ought to drive consideration squarely in her favor.

Judge Coggins positively influences those in her charge. This speaks well for the character of a person. Two of the three immediate past presidents of Wiley Manuel have worked under her supervision. Here is what they have to say:

When Judge Coggins was a litigation associate at a law firm, she was a consummate professional. Judge Coggins was thoughtful, patient, gracious, and generously interacted with subordinates, peers, and supervisors. She opened a door for me to walk through and achieve success. I am deeply grateful to her.

While working with her there in a quasi-judicial position, Judge Coggins exuded justice and fairness. Personally, I could not ask for a better friend and confidant.

Judge Coggins, just in the way she performs her duties as a lawyer and jurist, makes an indelible impact upon the people who engage her. Her tact, grace, intellect, and character leave an unforgettable impression. Her very presence on the bench will inspire confidence in our legal system, which is essential for our great democracy succeed and thrive. We currently find ourselves in a pivotal moment when confidence in our representational democracy and our system must be
