Dear Chairman Durbin and Ranking Member Grassley:

We write in enthusiastic support of Tiffany Cartwright's confirmation to the United States District Court for the Western District of Washington. Like Ms. Cartwright, we are former law clerks to the Honorable Betty Binns Fletcher of the United States Court of Appeals for the Ninth Circuit. Ms. Cartwright also has experience with federal criminal procedure and sentencing laws and guidelines

as result of her representation of accused and incarcerated persons. Finally, Ms. Cartwright has briefed and argued appeals in both the Ninth Circuit Court of Appeals and the Washington State Supreme Court.

Ms. Cartwright has the temperament that every lawyer and litigant hopes for when they go before a judge.
