It is my pleasure to write this letter of recommendation on behalf of Judge J. Michelle Childs, the nominee of President Biden for a position on the U.S. Court of Appeals for the District of Columbia Circuit.

I have been a practicing lawyer in the State of South Carolina since 1982. I served as Chairman of the House Judiciary Committee during my time in the S.C. House of Representatives, and as a member of our Judicial Screening Commission that examined judicial qualifications. In 1998, I was elected Governor of South Carolina, and served in that capacity until 2003. I currently practice law with McGuireWoods, LLP, and serve as President and CEO of McGuireWoods Consulting, LLC.

I have known Judge Childs for over twenty years, and strongly believe she would be an outstanding member of the U.S. Court of Appeals. She first came to my attention after I

was elected Governor in 1998, as she was a well-regarded young Labor and Employment lawyer in a prominent South Carolina law firm. I appointed her to serve as the Deputy Director of a cabinet agency, leading the division that oversaw all labor and employment issues in the state. After two successful years in that job, I nominated her for an administrative law position on the South Carolina Worker's Compensation Commission. This led to her election by the South Carolina legislature to serve as a Circuit Court Judge, followed by her selection by President Obama in 2010 to serve as a U.S. District Court Judge for the District of South Carolina.

As a member of my Administration, and later as a judge, Judge Childs demonstrated great qualities- intelligence, maturity, humility, a strong ethical compass, an outstanding work ethic, and an ability to work well with others. I have observed her in the courtroom, and she consistently treats people well, giving litigants and lawyers a fair hearing. She also brings a great deal of real-world experience from her work as a lawyer, agency leader and community leader that have proven invaluable in her role on the bench.

One final comment- she was selected as an agency head by a Democratic Governor, and then chosen for the state court bench by a majority Republican legislature. This speaks well of her strong reputation for fairness and integrity across our state.
