Dear Chairman Durbin and Ranking Member Grassley:

As the Former U.S. Attorney for the District of Puerto Rico, I write to recommend María Antongiorgi, Esq. for the position of U.S. District Judge for the District of Puerto Rico, which currently has three judicial vacancies. As evidenced by her Curriculum Vitae, and what I assume must have been an excellent background report, Ms. Antongiorgi is uniquely qualified for the position, being an excellent professional and public servant.

Personally, I have devoted my entire life to public service, first devoting ten (10) years of service to the P.R. Department of Justice and later, by devoting 30 years of service to the U.S. Department of Justice, where I held the position of Assistant U.S. Attorney (1988 – 1994), Executive Assistant (1994 – 2002), First Assistant (2002 – 2006) and that of United States Attorney (2006 – 2019).

Having closely worked with members of the P.R. Puerto Rico needs a judicial nominee with vast and proven litigation experience, integrity, and unquestionable commitment to the rule of law who can hit the ground running upon appointment. That candidate, without a doubt, is María Antongiorgi.

I have known Ms. Antongiorgi for over twenty (20) years, and I can attest that it is rare for someone to possess the vast and well-rounded experience and credentials that Ms. Antongiorgi has for the position of District Judge. For the past four (4) years she has held the positions of Deputy Clerk and Clerk of Court. Because of her current duties she stands in a privileged position, partnering with the Chief Judge in the Court's administration, and in the design of protocols and guidelines regarding case management, trial proceedings and jury selection processes, among others. In the development of these procedures, Ms. Antongiorgi's knowledge on 1<sup>st</sup>, 4<sup>th</sup> and 6<sup>th</sup> amendment rights proved to be crucial. She has a superb knowledge of court governance and federal judiciary policies and practices. Since her years in private practice, Ms. Antongiorgi has been a regular collaborator of the Court as it pertains to training for judicial officers and court personnel on EEO or EDR matters, protocols and procedures and Outreach programs. More so, currently she is also an active member of all court committees (Local Rules, Bar Examination, Criminal Justice Act, and Jury Utilization, among others), distinction that she shares only with the Chief
