We write to express our unqualified support for the nomination of Steve Dettelbach to be the Director of the Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF"). We are former prosecutors and defense attorneys who worked with or observed Mr. Dettelbach firsthand, or became aware of his reputation when he was an Assistant United States Attorney and then Deputy Branch Chief in the District of Maryland. We all agree that based on his integrity, leadership and abilities as a lawyer and manager that Mr. Dettelbach can lead the ATF effectively and honorably as it seeks to impartially and effectively enforce the law and fight violent crime.
