Since October 10, 2012, I have served as United States Magistrate Judge for the United States District Court for the District of Colorado. I was appointed by the United States District Court for the District of Colorado, and reappointed in 2016 and 2020. I was recommended by the statutorily required selection panel and unanimously appointed by the District Court. As a magistrate judge, my jurisdiction is governed by 28 U.S.C. § 636.

While I have jurisdiction within the entire District, my duty station is in Grand Junction, and the area I preside over roughly covers east to west from the Continental Divide to Utah and north to south from Wyoming to Ouray. In addition, I substitute frequently for the magistrate judge in Durango, which duty station often addresses laws and attendant issues regarding the two Indian Tribes with Reservation Land in Colorado and issues unique to the Four-Corners area. As a result of numerous recusals, I preside over a significant number of supervised release violation matters arising from both the Ute Mountain Ute Reservation and the Southern Ute Reservation. At times, I preside in Denver or other locations in Colorado. On one occasion, I have been granted extraterritorial jurisdiction by the Department of Justice and my Chief Judge to handle an international prisoner transport in Trinidad and Tobago.

I am involved in federal cases in a variety of fashions—my duties differ from those of full-time magistrate judges. As the magistrate judge assigned to Grand Junction, I have the primary responsibility for all petty offense and misdemeanor actions arising from federal lands in this portion of the state. The court over which I preside handles approximately 450 such actions per year. Since 2015, due to the operation of the Western Slope protocol, I have also handled significant portions (except for trial and sentencing) of most felony criminal matters arising from the Western Slope/Jury Division 3 area – approximately the northwest quarter of Colorado. My involvement in these matters includes everything from the inception of the criminal action (indictment, detention, arraignment, and trial setting) through substantive motions (on recommendation) to and including changes of pleas as well as post-conviction supervised release violation matters. Concerning most criminal actions emanating from the Western Slope protocol, the only involvement of the District Judge is for sentencing and jury trial for the limited number of defendants who proceed to trial. My criminal responsibilities also include reviewing and approving warrant applications and other miscellaneous filings.

On the civil side, by statute, a part-time magistrate judge may not be directly assigned a civil action in a presiding role, e.g., on the wheel, but may receive consent to preside over such an action in a different fashion. The consent process for a part-time magistrate judge—although specifically authorized by the Tenth Circuit—is rarely utilized. I have presided over 6 matters in that fashion. I have not had final responsibility for the judgment as to the remainder of the civil matters, although I am frequently referred

motions to dismiss and motions for summary judgment for recommendation. In addition, in the referral role, I generally have responsibility for discovery, settlement conferences, case planning, and non-dispositive issues.

Since 2014, I have been the supervisor of the *pro se* intake division for the District of Colorado. The *pro se* intake division is comprised of eight permanent law clerks across six positions who review all *pro se* prisoner cases and all *pro se in forma pauperis* (IFP) actions for non-prisoners. The intake division handles a significant number of cases per year, the largest single component of the District of Colorado's civil docket. I personally review all substantive orders to amend or cure initial filings, orders to deny IFP status (on recommendation), and orders to dismiss or partially dismiss (on recommendation). I draw all matters to the Court as a whole (except for partial dismissals, which are drawn within such order). I preside over each of these matters until a recommendation to dismiss or partially dismiss is issued or until the matter is randomly drawn onto the Court's docket. Annually, approximately 75 percent of these matters are resolved, in whole or in part, upon recommendations issued during the time I preside over the action. During the spring of 2020, I was responsible for significant changes to the review process in order to address the urgent and essentially injunctive nature of prisoner requests in COVID-19-related actions.

Plaintiff sued defendant medical product manufacturer for product liability after undergoing a total hip arthroplasty of the right hip in August 2008. Plaintiff raised four claims for relief: (1) strict liability against Defendant Stryker; (2) negligence against Defendant Stryker; (3) breach of warranties against Defendant Stryker; and (4) violation of the Colorado Consumer Protection Act (CCPA) against Defendant Stryker. Defendants moved to dismiss and argued that Plaintiff's claims were expressly preempted because the claims were based on the alleged failure of a § 510(k)-cleared device in combination with a Pre-Market Approved (PMA) device. I recommended that the motion to dismiss be denied, which was adopted by the District Court. I recommended denial on the basis that a colorable claim had been plead regarding lack of FDA preemption. Garfield County filed a cease-and-desist order against RMR Industrials as to RMR's plan to expand from limestone mining to potential dolomite extraction and as to RMR's assertion of the acreage from which it could extract. I found it appropriate to stay the matter and allow parallel litigation to proceed in Colorado State Courts, which was filed a few days before the matter was filed in federal court. The Plaintiff had strategically determined to file a proceeding in state court and then later file this action in Federal Court. Based on the timing of the filings and various abstention doctrines, I determined that matter should be initially heard in state court. Under State Court Rule 106, Colorado courts may determine whether a governmental body has exceeded its jurisdiction of abused its discretion. The matter was ultimately dismissed after the recommendation to dismiss or stay was adopted and the matter was stayed and administratively closed.

Multiple defendants were charged with violations of the Lacey Act for conspiring

to illegally hunt mountain lions and bobcats for profit in both Utah and Colorado from 2007 to 2010. Defendants would tree and capture the animals, cage them, and then release them on subsequent days in a manner that would allow paying clients to more easily find and kill them. I presided, with consent under the Western Slope Protocol, over all cases related to the conspiracy.

My recommendation to deny Defendant Simms' motion to dismiss was adopted by the district court. Copy supplied. Defendant had challenged the government's ability to proceed with the action, asserting that the conspiracy had concluded more than five years before the charges were brought, i.e. outside the statute of limitations, and that in any event he had withdrawn from the conspiracy. I determined that, at the pleading stage, the government had sufficiently charged and provided discovery as to the dates of the conspiracy such that a jury could find defendant's actions to have occurred within the charged or discovered dates, and that whether defendant withdrew from the conspiracy was a factual matter more properly considered by the jury. Festini-Steele v. ExxonMobil Corp., 2019 WL 5095695 (D. Colo. 2019), 2019 WL 6242809 (D. Colo. 2019), No. 20-1052, 2021 WL 629755 (10th Cir. Feb. 18, 2021). I recommended dismissing this action on the basis that the separation agreement in a dissolution of marriage action did not meet the definition of a qualified domestic relations order (QDRO). The district judge adopted the recommendation in full. The Tenth Circuit, reviewing *de novo*, determined that the agreement was a QDRO and reversed and remanded.

Estate of George v. City of Rifle, No. 20-cv-00522-CMA-GPG. The district court accepted in part and rejected in part the report and recommendation wherein I recommended, inter alia, dismissing the municipal liability claims in this excessive force case. The court determined that the plaintiffs should have the benefit of discovery to further establish a plausible claim for municipal liability. Copies supplied.

St. Paul Fire & Marine Ins. Co. v. Jones, No. 20-CV-00389-WJM-GPG, 2021 WL 5415869 (D. Colo. Nov. 19, 2021). This is an insurance coverage dispute seeking declaratory judgment as to coverage in a parallel state proceeding. I granted the defendant's motion for a stay and the Court lifted the stay after determining that the Mhoon factors weighed against granting a stay. Copy supplied.

Wehr v. U.S. Bank, Nat'l Ass'n, 2019 WL 8750265 (D. Colo. September 23, 2019), , 2020 WL 1242945 (D. Colo. Mar. 16, 2020). The Court accepted in part and rejected in part my recommendation to dismiss a portion of the claims and deny the motion to dismiss regarding four of the claims raised by a pro se plaintiff. The court declined to remand the claims to the state court, as I had recommended, and instead dismissed the claims without prejudice.

Perkins v. Suzuki Motor Corp., 2019 WL 13104644 (D. Colo. April 28, 2019), 2021 WL 5629067 (D. Colo. Feb. 19, 2021). I granted the plaintiff's motion to compel. The defendant filed a new declaration and exhibits after the order was issued. I declined to reconsider the order based on the untimely submission of new evidence. The court reviewed the new evidence and sustained the defendant's objections.

Robinson v. Oil Shale Corp., 2018 WL 510278 (D. Colo. January 23, 2018), 2018 WL 1256512 (D. Colo. Mar. 12, 2018). I recommended denying in part Defendant The Oil Shale Corporation's (TOSCO) motion to dismiss. The district judge sustained objections to that recommendation by Defendant TOSCO and dismissed the matter for failure to state a claim. The District Court adopted the recommendation granting co-Defendant XTO's motion to dismiss for failure to

state a claim.

United States v. Beider, 17-CR-152-MSK-GPG. I recommended from the bench that defendant's motion to suppress be denied and was overruled by the district judge on defendant's objection. The district judge found that the arresting officer did not have reasonable suspicion to support the traffic stop or subsequent investigation and therefore granted the motion.

Farris v. Ohio Sec. Ins. Co., 2016 WL 7338033 (D. Colo. December 19, 2916), 2017 WL 1390670 (D. Colo. Mar. 28, 2017. The court declined to adopt my report and recommendations granting the defendant's motion for summary judgment and denying the plaintiff's motion for certification of a question of law to the Colorado Supreme Court. Instead, the court dismissed for other reasons and therefore declined to adopt the recommendations.

United States v. Blanc, 14-PO-65-GPG. This matter, involving threats to National Forest Service personnel and damage to public lands, proceeded to a bench trial and Defendant was convicted on 10 of 14 counts and ordered to pay \$30,000 in restitution. Defendant appealed. The district court overturned the conviction as to count seven. The district court further found that restitution should have been considered and possibly ordered under 18 U.S.C. § 3563(a) rather than under 18 U.S.C. § 3663(a)(1)(A). The district court reduced the restitution amount to \$6,230. Copy supplied.

McFadden v. Meeker Hous. Auth., No. 16-CV-2304-WJM-GPG (D. 238, Aug. 14, 2017 (filed under seal)), 2018 WL 1203163 (D. Colo. Mar. 8, 2018). I denied the plaintiffs' various motions to seal or restrict. The district court sustained some of the plaintiffs' objections and overruled the order, except for the portion regarding sanctions against the defendants.

Williams v. McKee, No. 13-CV-02546-PAB-GPG, 2014 WL 4627781 (D. Colo. Sept. 15, 2014). I recommended that the Court grant the plaintiff's motion for leave to amend. The District Court rejected this recommendation and granted the defendants' motion to dismiss. Copy supplied.

Regarding my role supervising the *pro se* intake division, there is an automatic recusal policy for these cases. I am automatically recused if I am a party to the action or if the matter includes, as a party, any judge from the 21st Judicial District (Mesa County) or the District Attorney or any Deputy District Attorney for that jurisdiction. The recusal for the Mesa County officials is due to my continued private practice in that jurisdiction. With some regularity, *pro se* litigants sue judicial officers who have previously presided over their cases, resulting in a number of suits per year in which I am a named party and must recuse myself. I have not kept records of all automatic recusals issued by the Court as this is a purely administrative task handled by the Court Clerks. Also, a number of *pro se* litigants have moved for recusal on the basis that I have issued orders contrary to their position. This is typically not a valid basis for recusal, shows no animus on my part, and such a motion will most likely be denied. I do not have a record of these occurrences. On occasion, such motions are addressed by minute order by the district judge without my knowledge or involvement.

I have recused myself in a number of matters arising before me on the Western Slope. These have typically been necessitated by prior knowledge or representation of a particular litigant.

I believe that all my recusals have been either automatic or *sua sponte*. Other than litigation from the *pro se* intake division, I do not believe that a party has requested my recusal nor have I denied such a request except in that setting. I recused *sua sponte* in the following cases.

American Eagle v. Athena Enterprises, 20-CV-2743-DDD-GPG. I recused myself, sua sponte, after the parties notified me that I previously had represented the owner/president of one of the corporate entities in my private practice for an unrelated matter. Although I had not previously known that the client had any involvement with the corporation and the matters were unrelated, I believed the recency of the representation—within the prior year—created an appearance of impropriety necessitating recusal.

United States v. Harbin, 20-CR-164-CMA-JMC. I previously represented Defendant in state court for a similar matter. I found recusal was mandatory and I sua sponte recused myself.

Godbey v. Johnson, 16-cv-1823-NYW. I recused myself sua sponte. The defendant in this action is a local process server who had been periodically hired by my office, and I found that presiding over the action would have created an appearance of impropriety.

Burns v. Pohto, 15-cv-2326-REB-NYW. I was representing this defendant in a state criminal action at the time he was sued in federal court. I recused myself sua sponte as there was no way of curing the conflict of interest.

Hamilton v. Boyd, 15-cv-1107-LTB. I recused myself sua sponte. The plaintiff in this action sued a state court judge before whom I had a pending criminal action in my private practice. Presiding over the action would have created an appearance of impropriety.

United States v. Thompson, 13-cr-430-REB; United States v. Thompson, 11-mj-35-DW. I recused myself sua sponte. I was sharing office space with defense counsel at the time of my appointment and had some familiarity with the case. There was no method of curing the conflict.

Additionally, I have recused myself *sua sponte* and from the bench on several criminal matters. These arose from my in-court recognition of the defendant, usually from prior representation or knowledge in the community. The names and records do not populate in the Court's computer system because the rulings were oral, rather than by written order. My recollection of those is as follows:

United States v. Minor, 14-mj-38-CBS. I previously represented Defendant in a state case for a hunting violation. He was charged with a similar violation on federal land. I deemed that to raise a conflict and recused myself *sua sponte*.

Unknown case number. One Defendant was the son of a prior client whom I had represented several times. It was clear from the citation that the father (my former client) was a potential witness as to credibility for the defendant. I deemed this to raise a conflict and recused myself.

In two multi-defendant matters arising out of the Western Slope Protocol, I have screened myself from work related to a single defendant but maintained the referral role for codefendants. These include *United States v. Briceno-Quijano*, 19-cr-535-CMA-GPG, in which I was representing/represented the husband of Defendant Cruz-Gomez and *United States v. Duarte*, 21-cr-395-CMA-GPG in which I previously represented Defendant Duarte. This partial screening, approved by the presiding district judge, allowed me to continue my involvement as the referral magistrate judge without any appearance of impropriety or conflict.

During law school, I clerked for Underhill & Underhill, P.C, a small business firm just south of Denver. I was hired as an associate upon passing the bar examination in the fall of 1996.

I was hired by the Mesa County District Attorney's Office (21st Judicial District) in February 1997 and began work there in March. I served in that position until July 2000. During that time, I tried more than seventy-five jury trials to verdict inclusive of misdemeanors and felonies. At the time of my departure, I was the lead county court prosecutor.

In July 2000, I opened my own law office focusing primarily on defending those accused of crimes in state and municipal courts on the Western Slope of Colorado. I have continually been engaged in private practice as a sole practitioner for over twenty years. In addition to criminal actions, I have handled what I consider to be related cases, such as restraining orders and actions filed to seal criminal records, topics on which I have written articles in order to assist other attorneys. My practice has been wideranging from traffic and misdemeanors to serious felonies.

From 2000 to 2012, I represented a sizeable number of defendants as a contract attorney for Alternate Defense Counsel (ADC). ADC is charged with affording representation to indigent defendants in juvenile and criminal actions when the public defender has a conflict. During the first several years of private practice, ADC work made up the bulk of my caseload. I handled matters for ADC primarily in Mesa County and upon request in both the 7th and 9th Judicial Districts. I was also assigned Rule 35(c) matters, a pre-appeal motion for post-conviction review allowed under Colorado law. I continued to accept ADC cases, as an assigned courtroom attorney and, later, upon special assignment, until I joined the bench in 2012, at which time I significantly reduced my state criminal practice to afford sufficient time for my new duties.

In private practice, my clients have been individuals under investigation for, charged with, or convicted of a variety of criminal offenses by the State of Colorado. I have represented individuals from all walks of life,

I have frequently represented individuals at no cost or a significantly reduced fee in criminal actions in state court. These individuals are poor and sometimes disabled. This representation can include legal advice on specific issues up to and including entire-case representation. My prior role on the Board of the Community Food Bank and current role with the Riverside Educational Center have significant legal components (as I am not allowed to be involved in fund-raising)—thus, I satisfy some of my Board volunteer requirements to those agencies by way of legal work. I also serve by mentoring young lawyers, college students, and high school students regularly. Such mentoring includes internships of various lengths as well as co-establishing and working with the mentoring program within the Minoru Yasui American Inn of Court. I frequently volunteer to speak at local middle schools, high schools, and at the university level.

I submitted an application, jointly to both Senators Bennet and Hickenlooper, in March 2022. I was interviewed by the Nominating Commission appointed by the senators on April 19, 2022. I was interviewed by Senators Bennet and Hickenlooper on April 22, 2022. The following week I was informed that I, along with two other candidates, was being recommended to President Biden for possible nomination. I had previously been interviewed by the White House Counsel's Office in October 2021 for a prior vacancy, for which I was not nominated. Since May 26, 2022, I have been in contact with officials from the Office of Legal Policy at the Department of Justice. On September 6, 2022, my nomination was submitted to the Senate.
