Ms. Clarke was a freshman when I was a senior in college, and while we only met in passing, via our mutual friend and former Assistant US Attorney Alvin Bragg, who was her predecessor as President of the Harvard Black Students Association. Throughout Ms. Clarke's life and career, she has advocated for fairness and justice, and I have been extremely impressed by her commitment to protecting the rights of every person in this great country.

While Ms. Clarke and I might likely disagree on many policy debates, I have no reservations about her qualifications to become the Assistant Attorney General of the Civil Rights Division. I know well several individuals who have led the Civil Rights Division in both Republican and Democratic Administrations, and I firmly believe that Ms. Clarke's sterling credentials, her integrity, and her commitment to the rule of law make her an outstanding choice to lead that Division.

Thus, I was very pleased when I learned that President Biden had nominated Ms. Clarke. I urge the Senate Judiciary Committee to swiftly process her nomination, and for the Senate to quickly confirm her. She has this Republican's full and enthusiastic support.
