from 2011 to 2016, I served as the Director of the Office of Safe Schools Advocate and in 2015 as the interim Director of the Office of Juvenile Justice and Delinquency Prevention under the Pennsylvania Commission on Crime and Delinquency. In this role, I interacted with numerous statewide agencies that were focused on children, education, crime prevention strategies, policy development, and requests for performance reviews and grant awards.

Approximately six years ago, I entered private practice and currently work on matters that address civil rights, employment law, education law and Title IX, government and regulatory compliance, and investigations. My clients consist mostly of colleges and universities, elementary and secondary schools, private companies, and non-profit entities.

For the first fourteen years of my career, I represented indigent individuals charged with criminal offenses, and, as a prosecutor, victims of crime. In recent years, with the exception of my tenure as the District Attorney of Philadelphia, I have advised entities (i.e., educational institutions, private companies, and non-profit entities) on issues concerning education law, risk assessment, compliance, and labor and employment matters. I regularly work with executive leadership and/or directors of various institutions, corporate and/or non-profit entities and law enforcement.

From 1997 to 2011, one hundred percent of my practice was in state court as a trial attorney. As a public defender in Richmond, Virginia, I appeared in court on nearly a daily basis and handled over 1,400 cases from 1997 to 2003 ranging from misdemeanor theft to murder. I also served in a supervisory capacity. Beginning in 2004 as a prosecutor in Pennsylvania, I appeared in court on a daily basis. I handled a wide array of cases ranging from theft to attempted murder. On average, I would handle 15 to 30 cases daily. In 2007, I was promoted to a supervisory role in the District Attorney's office. As a supervisor, I continued to appear in court regularly in addition to reviewing cases, observing trials, and handling complex or sensitive matters for trial. I also managed a variety of specialized courts such as DUI Treatment Court, Veteran's Court, and Mental Health Court. I negotiated a guilty plea in this case on August 21, 2007. The victim in this case was an elderly woman. The Defendant knew the victim and would help her with household repairs or running errands. The Defendant would also play the lottery numbers for the victim. Late one night the Defendant broke into residence of elderly victim while she was sleeping and stabbed her repeatedly about her head and upper body as she slept. Police located clothing of the Defendant that appeared to be stained with blood that was found in a trash bag outside of the Defendant's home as well as what appeared to be blood-stained clothing in his home. DNA analysis linked the soiled clothing and other forensic evidence located in the home of the Defendant to the victim and did not exclude the defendant's DNA as a contributor. Defense counsel filed and argued a pre-trial motion to suppress the DNA evidence, which was denied by the Court. The Defendant pled guilty to attempted murder, burglary, and

possession of an instrument of crime and received a sentence of 20 to 40 years in a state correctional institution.

Throughout my career as an attorney, I have always pursued various legal activities that have expanded the scope of my work and the depth of my experiences. As a public defender and prosecutor, while most of my time was spent on preparing for trial or trying cases, there were numerous other areas of legal significance in which I participated.

For example, my work with diversion courts as a prosecutor has been one of the areas of greatest legal impact and significance to me. I was the first attorney who supervised and staffed Veterans Court when it began in Philadelphia. Veterans Court was one of many diversion courts that I either handled matters in or supervised while serving as an Assistant District Attorney. I also handled matters in the following diversion programs: Juvenile Drug Court, DUI Treatment Court, Mental Health Court, Small Amount of Marijuana (SAM) Court and a court called "Project Dawn" that focused on women who were repeatedly arrested for prostitution and were being trafficked. These experiences aided in my serving as the District Attorney of Philadelphia, where I worked to restore public and internal confidence in the office and the role of the prosecutor. While I was not involved in trying cases personally as District Attorney, I was the decision-maker at a time when issues such as the opioid epidemic, officer-involved shootings, increased concerns surrounding hate crimes and growing violence all required immediate attention. Additionally, I was responsible for administrative oversight, managing a budget and an office of approximately 300 attorneys and 300 staff, and collaboration with other local, state, and national entities.

In private practice, I have conducted internal investigations, often involving allegations of sex or race discrimination or harassment, for clients in various arenas and at all levels, including senior leadership. I have also led independent investigations into matters involving law enforcement and use of force. The investigations require extensive and detailed review of documents, interviews of many individuals and extensive analysis along with findings and advisement to the client.

In addition to my work in conducting internal investigations, I have also represented clients that have had senior members of their organization accused of discrimination. While in private practice, I have served as an adjudicator for various colleges and universities on matters involving sexual harassment under Title IX or violations of the student code of conduct.

Beyond my work in private practice, I have heard cases as a senior member of the Pennsylvania State Disciplinary Board hearing committee. I also have been appointed by two governors of Pennsylvania to serve on commissions that were tasked with addressing some of the most critically important issues to Pennsylvania citizens, school safety and law enforcement engagement with the community.

Additionally, I serve on the Independent Reconciliation and Reparations Program Oversight Committee to address clergy sex abuse for the Archdiocese of Philadelphia and have done so since 2018. I also developed a Title IX Compliance toolkit and training within two months of starting at my current firm. I serve as an adjudicator in hearings involving Title IX. Lastly, I continue to train and mentor other attorneys and have taught courses as an adjunct professor of law over the course of my career.

I have not engaged in any lobbying activities and have never registered as a lobbyist.
