Dear Dr. Shogan:

I write to request records relevant to the Senate Judiciary Committee's consideration of the nomination of Pamela Jo Bondi, President-elect Trump's presumptive nominee to be Attorney General.

From January 2019 through November 2019, and again from January 2020 to present, Ms. Bondi has been a lobbyist with Ballard Partners. In this role, she has acted as a *Foreign Agents Registration Act* (FARA) registered lobbyist on behalf of several foreign governments or officials, including the government of the Dominican Republic, the Embassy of the State of Qatar, the Minister of Foreign Affairs of the Republic of Zimbabwe, and the Republic of Kosovo. To understand the extent to which her work as a lobbyist may create potential conflicts of interest should she be confirmed as Attorney General, the Committee requires additional information from the National Archives and Records Administration that is not otherwise available. To that end, please provide the following information:

- 1. All records between January 1, 2019 and January 20, 2021 reflecting or relating to communications between and among White House officials, and with any executive branch employee, concerning or including Ms. Bondi.
- 2. All records between January 1, 2019 and January 20, 2021 reflecting or relating to meetings between White House officials, and any executive branch employee, concerning or including Ms. Bondi. These records should include:
 - a. Purpose and attendees of the meetings;
 - b. Notes or transcriptions from the meetings; and
 - c. Communications about the meetings.

Please provide these materials as soon as possible, and no later than January 15, 2025. I appreciate your prompt attention to this important request.
