Dear Chairman Durbin and Ranking Member Grassley:

It is with great enthusiasm that I recommend Judge Trina Thompson to serve as a federal judge on the District Court for the Northern District of California.

Judge Thompson has served with distinction on California's Superior Court bench since 2001. She has been the embodiment of the greatest ideals of our justice system by presiding over all manner of dispute in an impartial, independent, fair and timely manner, ensuring that due process is guaranteed in accordance with federal and state law. This is the most we can ask of a new federal trial judge.

Across the California state judiciary, in organizations such as CJA, Judge Thompson enjoys the admiration and respect of her peers. She is a diligent worker, actively shares her experiences and expertise in decision-making processes, and always has a ready smile, encouragement, collaboration and support for her colleagues. She is unflappably calm in all situations, and by unconscious habit considers issues on their individual merits within the broader context of settled federal and state constitutional law. She has excellent judgment, displays the highest levels of integrity, and her readiness for this federal District Court challenge.

Judge Thompson is exceptional. Her treatment of others, compassion, integrity, professional demeanor and breadth of experience handling complex cases make her stand out among other judges and provide a role-model for public servants.
