Court leadership comes in various forms. Judge Thompson has experienced many of them. She has supervised one of our busiest criminal courthouses (2003-2006) and been chosen to serve as Presiding Judge of the Juvenile Courts (2010-2011). These positions of increased responsibility require strong management skills and collaboration with justice stakeholders and community groups. We have also profited from the judge's leadership on judicial committees where court policy is often formed, and plans are devised to carry out the court's mission. Judge Thompson has led our Community Outreach, Education, and Information and Technology committees where she has brought fresh ideas to support our best work. These features of her state court work will likewise serve the federal district court well.

The judge's leadership also extends to her involvement in statewide judges' groups like the Association of African American Judicial Officers of California and the Center for Judiciary Education and Research on its Judicial Branch Ethics and Fairness Curriculum Committee. Both positions affirm how Judge Thompson is held in high regard by her judicial peers. Nationally, the judge's appointment to the Coordinating Council on Juvenile Justice and Delinquency Prevention further recognized the value of her contributions. Judge Thompson's prodigious body of work has been often distinguished by local, state, and national legal and civic groups. Over the years, the judge has received no less than 24 awards recognizing her service on the bench and in the community.

Judge Thompson's contributions to the judicial branch and legal profession generally expand far beyond the walls of her courtroom. She believes that the wealth of knowledge, experience, and skills garnered throughout her career is something to be shared with other judges, attorneys, students, and the public at large for our collective benefit. Accordingly, for example, Judge Thompson has presented judicial trainings to our judges and is currently assisting, at my request, the development of a series of informal lunchtime training sessions concerning jury trial management. But when I think of Judge Thompson's career to date, I am particularly impressed by her commitment to mentoring newer judicial officers, lawyers, and young people. She makes herself available to people, schools, and youth programs and has been a popular speaker on civics related topics. I believe that she views this informal mentoring and teaching as a responsibility of her position. She has always carried herself as an example to others and, by doing so, has been an inspiration to many — including me.

On a personal note, Judge Thompson is wonderful colleague who brings integrity and respect to the judicial institution through her high-quality work on and off the bench. She has always been, and will continue to be an honest, thorough, and purposeful public servant. While her departure from the state court will be a loss for our county, her confirmation to the federal district court will be an unqualified triumph for the country. I offer my wholehearted support for her nomination.
