In offering these words of support for Judge Joun, I speak from my personal experience as well as my knowledge of his reputation as a lawyer and jurist. I can say without fear of contradiction that as a distinguished member of the bar, and now a highly-respected jurist, he is exceptionally well qualified for this honor. We congratulate the President on this outstanding nomination and trust that the Senate will confirm him at the earliest opportunity.

I first came to know Judge Joun in 1999 when we served together on the Individual Rights and Responsibilities Section of the Massachusetts Bar Association. Until I was appointed to the bench a few years later, our paths crossed often as civil rights practitioners. He impressed me then as an able and committed advocate in a field of law that carried no guarantee of fame or fortune. When Judge Joun was appointed to the Boston Municipal Court in 2014, I celebrated the Governor's choice because I knew the court would benefit from his long history of community service, commitment to equal justice and, of course, his deep knowledge of the law. By all accounts, Judge Joun has been an outstanding jurist both in the courtroom and beyond. He is highly regarded among members of the bar as a judge who is fair to the litigants and their advocates, and he is known as a judge who always strives to honor the dictates of the law in his decisions. Just as important, he enjoys a reputation as a judge who, without fail, is respectful of the dignity of the people who appear before him. I know of no one, in or out of the legal profession, who has called into question Judge Joun's personal or judicial integrity.
