**Re: Over 1800 Americans—including Over 1400 Lawyers—Support the Nominations of Kristen Clarke and Vanita Gupta**

Dear Senators Durbin and Grassley:

On behalf of Lawyers for Good Government, 1404 lawyers, and 456 non-lawyers in all 50 states, the District of Columbia, and Puerto Rico we write to strongly urge you to support the nominations of Vanita Gupta for the position of Associate Attorney General and Kristen Clarke for the position of Assistant Attorney General for Civil Rights. We also encourage you to support the nomination of other experienced civil rights attorneys like Vanita Gupta and Kristen Clarke for future political and judicial nominations.

Over the past four years, Donald Trump and his administration worked to undermine civil and human rights, defended voting laws that restrict access to the vote for people of color, challenged affirmative action policies, attempted to undermine the census, scapegoated immigrants and Black Lives Matter protestors, encouraged a white supremacist insurrection on the nation's seat of power, and gave people who support many of these efforts lifetime appointments to be judges.

Trump did profound damage to our institutions, and to repair that damage, we need people who have devoted their lives to fighting against injustice—we need Vanita Gupta, Kristen Clarke, and others like them. After years of leading the fight for civil rights at two of the nation's premier civil rights organizations, Vanita Gupta and Kristen Clarke represent the future of our country and the legal community's finest advocates.
