Since 2018, I have served as an Associate Justice of the Oregon Supreme Court. I was appointed to that position on January 2, 2018, by Governor Kate Brown and I was elected to a successive six-year term in November 2018. The Oregon Supreme Court is the highest court in the Oregon judicial branch and is primarily a court that reviews decisions in selected Oregon Court of Appeals cases. The Oregon Supreme Court selects cases with significant legal issues calling for interpretation of laws or legal principles. In addition to that discretionary review function, the Oregon Supreme Court hears direct appeals in death penalty, lawyer and judicial discipline, and Oregon Tax Court cases. Further, the Oregon Supreme Court may accept original jurisdiction in mandamus, quo warranto and habeas corpus proceedings. And the Oregon Supreme Court reviews ballot measure titles, prison siting disputes, legislative reapportionments, and legal questions on Oregon law referred to us by federal courts.

From 2006 to 2018, I served as a Circuit Court Judge, Department Four, Position Four sitting in the Multnomah County Courthouse in Portland, Oregon. I was appointed to the Multnomah County Circuit Court on February 17, 2006, by Governor Theodore Kulongoski and I was elected to successive six-year terms in 2006 and 2012. The Multnomah County Circuit Court is a state trial court of general jurisdiction.

In an action for forcible entry and detainer, plaintiff landlord sought to evict defendant tenants from a rental unit for nonpayment of rent. Defendants moved to dismiss the forcible entry and detainer action, arguing that the plaintiff's termination notice was invalid under Oregon Revised Statutes 90.394(3) because it stated an amount of rent that was greater than the amount that the trial court had determined defendants owed. The trial court denied the motion to dismiss, entered judgment against defendants, and the Oregon Court of Appeals affirmed. I authored the Oregon Supreme Court decision reversing, in which we held that, under Oregon Revised Statutes 90.394(3), a valid termination notice must specify the amount of rent to be

paid in order to cure the nonpayment of rent and that amount must be a precise and accurate amount, not a greater inaccurate amount. A landlord's failure to comply with the requirements under Oregon Revised Statutes 90.394(3) results in an invalid notice, requiring dismissal of the subsequent forcible entry and detainer action. The case was remanded for further proceedings.

2. Robinette v. SAIF, P.3d , 369 Or. 767 (Or. 2022)

The claimant injured her right knee at work and her workers' compensation claim was accepted for a right knee strain. Following her knee surgery, claimant's doctor closed the workers' compensation claim and claimant was awarded whole person impairment for the surgical value associated with the knee surgery. Upon reconsideration of the notice of closure, a medical arbiter found additional loss of use or function of claimant's knee, but attributed those findings entirely to non-workrelated causes. Claimant was awarded additional impairment value for chronic condition impairment, but did not receive any value for the reduced range of motion and decreased stability, based on the medical arbiter's findings that those were not related to the compensable injury. The Oregon Workers' Compensation Board upheld that award, but the Oregon Court of Appeals reversed. I authored the decision of the Oregon Supreme Court, holding that, when calculating permanent partial disability awards, each distinct loss of use or function of a body part is considered separately to determine if it qualifies as "impairment" - that is, "loss of use or function of a body part or system due to the compensable industrial injury" – under Oregon Revised Stature 656.214. The decision of the Oregon Court of Appeals was reversed. The order of the Workers' Compensation Board was affirmed.

3. Bank of N.Y. Mellon Tr. Co., Nat'l Ass'n v. Sulejmanagic, 481 P.3d 293 (Or. 2021)

In this case, the Bank of New York Mellon Trust Company had filed a civil action to foreclose a deed of trust on a condominium unit. Defendant Tanglewood Hills Condominium Association had a lien against the same unit for condominium assessments that had not been paid by the owner. After the bank's foreclosure action had been dismissed, Tanglewood gave notice of its lien under Oregon Revised Statute 100.450(7). More than 90 days later, the bank had the foreclosure action reinstated. Tanglewood contended that, under Oregon Revised Statute 100.450(7), its lien took priority over the bank's interest because the bank had not initiated a foreclosure action within 90 days. The trial court rejected Tanglewood's argument and granted summary judgment for the bank. The Oregon Court of Appeals affirmed. I authored the decision of the Oregon Supreme Court, in which we held that a first lienholder's foreclosure action against a condominium unit, previously filed but dismissed, was insufficient to retain priority over a condominium association's lien for unpaid condominium assessments when the condominium association gave otherwise proper notice under Oregon Revised Statute 100.450(7). The decision of the Oregon Court of Appeals was reversed. The judgment of the circuit court was reversed, and the case was remanded for further proceedings.

4. State v. McWoods, No. 16CR78185 (Multnomah Cty. Cir. Ct.)

The defendant was accused murdering of his one-year-old daughter, who was found

dead with broken ribs and methadone and methamphetamine in her system. The prosecutor argued that the toddler drank a Capri Sun laced with drugs while in the defendant's care, and the defendant caused her death through reckless and dangerous parental choices. The prosecutor also alleged that defendant influenced his mother to give misleading and false statements during the investigation. The defendant denied responsibility for the toddler's death and moved to dismiss the case based on lack of evidence. After analyzing the defendant's motions to dismiss based on evidence obtained from the search warrants. I denied the motion and determined that there was sufficient evidence for the charges – murder by abuse, manslaughter in the first degree, criminally negligent homicide, criminal mistreatment in the first degree, and tampering with a witness – to continue. I also denied the defendant's motion to reduce bail, applying the criteria for release in Oregon Revised Statute § 135.230(10). The case was reassigned when I was appointed to the Oregon Supreme Court. Thereafter, the defendant was found guilty of all charges by a jury. On July 13, 2022, the Oregon Court of Appeals reversed the murder conviction based on the removal of Black jurors during jury selection, and remanded the case for retrial to the trial court.

5. Closson v. Stapleton, No. 1002-02537 (Multnomah Cty. Cir. Ct.)

This medical malpractice case involving the drug overdose of Mr. Closson. The core question presented was whether the prescribing doctor negligently failed to inform Mr. Closson of the risks of not taking the prescribed dose as instructed and whether the doses where properly prescribed. I made evidentiary rulings based on objections of counsel regarding witness testimony about the defendant's medicine contract for his use of prescribed medication and evidence found in defendant's home. I allowed some of the evidence, including evidence of how the doctor created his electronic medical records for Mr. Closson, evidence of Mr. Closson's disclosure or nondisclosure of other prescribed medication, evidence of a pain medication contract and Mr. Closson's compliance or noncompliance with it, while other evidence, including evidence of the criminal investigation regarding irregularities and missing pills in the medical examiner's office, was excluded. After a week-long trial, the jury reached a verdict in favor of the defense. An appeal and cross-appeal were initiated

but subsequently was dismissed before any briefing occurred on the motion of the appellant and cross-appellants.

6. *Freitag v. Legacy Emanuel Hosp. & Health Ctr.*, No. 0807-09471 (Multnomah Cty. Cir. Ct.)

This was a medical malpractice case involving the question of whether Ms. Prodan, in her capacity as a registered nurse, placed Ms. Freitag, a quadriplegic, in her hospital bed in a manner that caused the surgical screws in Ms. Freitag's neck to loosen. Ms. Freitag was required to have an additional neck surgery to secure the screws. Ms. Freitag sued Ms. Prodan and Legacy Hospital, her employer.

Before trial, I made evidentiary rulings regarding witness testimony about Ms. Prodan's care and general interactions when Ms. Freitag was recovering in the hospital. I allowed some of the evidence, including Ms. Freitag's additional recovery time for the additional surgery and a simulated video of how Ms. Prodan placed Ms. Freitag in the bed, and denied the admittance of other evidence, including the existence of insurance. This was a personal injury case involving the Federal Employer's Liability Act, the Railway Safety Act, and the Safety Appliance Act. Mr. McMackin was a railroad employee of Union Pacific Railroad and injured his shoulder while on the job. Mr. Mackin sued Union Pacific, alleging that Union Pacific was negligent in causing the incident and that the incident caused him to suffer left shoulder and back injuries. Throughout the trial, I made various evidentiary and other rulings. Most notably, Union Pacific brought an expert that wanted to provide testimony about whether the speed and braking of the train was the cause of Mr. McMackin's injuries. I ruled that the expert's testimony could not be given, because a proper foundation was not laid and the expert was not qualified to give the intended testimony. After a two-week trial, a jury reached a verdict in favor of Mr. McMackin in the amount of \$1,795,227.00. Union Pacific appealed, and the Court of Appeals affirmed.

8. In the Matter of J. E. Dunn Nw. Inc. v. Salpare Bay, LLC., No. 0710-12536

(Multnomah Cty. Cir. Ct.)

This was a construction defect case involving the failed development of luxury condominiums, a boating dock and a marina, and a bank's failure to fund the development. J.E. Dunn Nw. began construction and built the seawall, the foundation, and other structural components of the development when the developer stopped paying the billings for work completed because he could not get additional bank funding. Without payment, J.E. Dunn Nw. could not pay the subcontractors and they sued for payment of services. This case was designated as a complex case by the Presiding Judge of the Multnomah County Circuit Court, and a receiver was appointed to assist with the case. Many of the subcontractors settled their claims before trial. The remaining parties stipulated to a court trial regarding the lien foreclosure issues and who would receive the property. There were motions seeking to limiting the scope of damages due to halt of construction. After consideration of the briefing, declarations, exhibits, and oral argument, I determined that the scope of damages would not be limited. Thereafter, discovery was completed, the parties agreed to a jury waived trial. I ruled in favor of the remaining plaintiffs on the lien foreclosure issues. Before a judgment could be entered, however, the bank was taken over by the Federal Deposit Insurance Corporation (FDIC), and the FDIC removed the case to federal court in case J.E. Dunn Northwest, Inc. v. Salpare Bay, LLC, Civil Case No. 09-1068-KI (D. Or. Oct. 26, 2009). The federal court then remanded the case to me, and I entered judgment for the remaining plaintiffs.

9. *Stephan v. Avamere Health Servs.*, No. Number 0611-11723 (Multnomah Cty. Cir. Ct)

This case involved the question of whether the treatment and care of an Alzheimer's patient by a residential facility was negligent. Mrs. Stephan, through her son as personal representative, sued the residential facility for negligence, negligence per se, and breach of contract for not providing care for as promised, failure to follow the Oregon Administrative Rules by not providing trained staff and the required level of care to her, failure to respond to Mrs. Stephan's dementia symptoms of anxiety and confusion, failure to protect Mrs. Stephan's cognitive, emotional, and physical wellbeing. There were hearings on summary judgment and other motions before the case

was assigned to me for trial. Prior to trial, I heard a number of motions and allowed an amended complaint so that the pleadings conformed to my rulings. During the trial, the patient died and her estate was substituted for the personal representative. Throughout the trial, applying Oregon's rules of evidence, I allowed evidence of communications made by the facility informing the family of level of care Mrs. Stephan needed during her time at the residential facility as her health declined, evidence the timeliness of the communications to Mrs. Stephan's family about treatment, evidence of injuries to Mrs. Stephan and whether the injuries were a result of lack of staff training and/or failure to meet the standard of care. I also excluded evidence regarding care of other patients living in the residential facility. After a two-week trial over which I presided, the jury reached a verdict for the plaintiff and awarded the plaintiff \$4,200 in economic damages for the cost of one month of housing, \$400,000 in noneconomic damages and \$500,000 in punitive damages. The defendant did not appeal.

10. *State of Oregon v. Deweese*, Nos. 0912-35107, 0912-35108, 0912-35109 & 0912-35111 (Multnomah Cty. Cir. Ct.)

In this case, four defendants were charged with tax evasion and fraud of state benefits for health care, childcare, subsidized housing, and public assistance through the receipt of food stamps. The prosecution alleged that the defendants defrauded the State by receiving benefits for child care and caregiving for a disabled person who was not disabled at the level claimed, and for children who were not supervised by them. Analyzing the evidence, I allowed the evidence regarding the circumstances of the benefits paid and witness testimony based on observations of the level of defendant's disability. I denied defendants' motion for judgment of acquittal, concluding that the State had presented enough evidence for each charge.

After a two-week court trial, I found defendants DeWeese, Gaither, and Stewart guilty of tax evasion and fraud of state benefits for health care, childcare, and public assistance through the receipt of food stamps, and I acquitted defendant Lee based on the evidence. Each of the defendants were placed on a five-year probation sentence. Defendant Stewart appealed her convictions. The Oregon Court of Appeals affirmed Ms. Stewart's conviction for tax evasion, her conviction for making a false claim for health care payment, her two convictions for unlawfully obtaining a food stamp benefit and three convictions for theft in the first-degree, but reversed her three convictions for making a false claim for health care payment and three convictions for theft in the first-degree, but reversed her three convictions. On remand, those convictions were reversed and remanded for resentencing. At resentencing, her three convictions for theft in the first-degree were dismissed and Ms. Stewart was sentenced to five-year probation sentence for the convictions that were affirmed.

D.O. v. Richey, No. 17SK02618, Dkt. (Multnomah Cty. Cir. Ct. Dec. 22, 2017) (copy supplied), rev'd, 456 P.3d 348 (Or. App. 2019). I granted the petitioner's stalking protective order. The respondent challenged the sufficiency of the evidence supporting the order. The Oregon Court of Appeals reversed, agreeing that there was insufficient evidence to support the order because the petitioner failed to meet her burden to show expressive and non-expressive contacts by the respondent, as required under the statute.

State v. Eatinger, No. 15CR38602, Dkt. ____ (Multnomah Cty. Cir. Ct. Nov. 24, 2015) (copy supplied), rev'd, 448 P.3d 636 (Or. App. 2019). A jury found the defendant guilty of driving under the influence of intoxicants. Following his conviction, the defendant appealed two of my rulings, namely, my decision that a police officer could testify about the defendant's performance and my denial of the defendant's motion to strike the officer's testimony because of the lack of an adequate foundation. The Oregon Court of Appeals reversed and remanded, concluding that State failed to present an adequate foundation for the officer's testimony, and that the challenged testimony should have been stricken. On remand, no action was taken because the defendant satisfied all probation conditions and had been early terminated from probation.

Bentley v. Multnomah Cnty. Sheriff's Office, No. 17CV11314, Dkt. ____(Multnomah Cty. Cir. Ct. June 2, 2017) (copy supplied), *rev'd*, 443 P.3d 743 (Or. App. 2019). I denied the petitioner's petition to possess a firearm because he had been previously convicted of robbery. The Oregon Court of Appeal reversed and remanded for entry of judgment granting the petition, concluding that the petitioner had established that he did not now pose a threat to the safety of the public or to himself.

Wingard v. Oregon Family Council, Inc., No. 16CV18238, Dkt. ____(Multnomah Cty. Cir. Ct. Oct. 27, 2016) (copy supplied), *rev'd*, 417 P.3d 545 (Or. App. 2018). The plaintiff, a former congressional candidate, filed suit against his political opponents, alleging common law defamation and violation of statute prohibiting certain false publications concerning a candidate. I denied the political opponents' motion to strike under the anti-Strategic Lawsuits Against Public Participation statute. The Oregon Court of Appeals reversed and remanded holding that the plaintiff failed to carry his burden of showing that the political opponents acted with actual malice in publishing the statement at issue.

Singleton v. FCA US LLC, No. 16CV30491, Dkt. __ (Multnomah Cty. Cir. Ct. Feb. 2, 2017) (copy supplied), rev'd, 395 P.3d 873 (Table) (Or. 2017). I denied a motion to

change venue. The defendants filed a petition for mandamus, contending that there were not sufficient contacts for the case to proceed in the venue. The Oregon Supreme Court granted an alternative writ of mandamus. On remand, I reversed my decision finding sufficient contacts for the case to proceed in the venue.

State v. Rahmaan, No. 15CR03167, Dkt. ____ (Multnomah Cty. Cir. Ct. Oct. 22, 2015) (copy supplied), rev'd, 405 P.3d 200 (Mem) (Or. App. 2017). The defendant appealed a judgment of conviction for two counts of second-degree robbery (Counts 1 and 2), one count of first-degree burglary (Count 3), two counts of forgery (Counts 4 and 5), two counts of identity theft (Counts 6 and 7), and one count of coercion (Count 8) arguing that second-degree robbery convictions should have merged. The State agreed with the defendant that there was error, as to the second-degree robbery. The Oregon Court of Appeal reversed the second-degree burglary counts and remanded for an entry of a judgment of conviction for one count of second-degree robbery. The Court of Appeals otherwise affirmed the judgment and remanded for resentencing.

State v. Garcia, No. 120545265, Dkt. ___ (Multnomah Cty. Cir. Ct. Oct. 5, 2012) (copy supplied), rev'd, 377 P.3d 596 (Or. App. 2016), aff'd, 399 P.3d 444 (Or. 2017). The defendant was charged with two counts of interfering with a peace office and one count of resisting arrest for her actions to prevent officers from arresting her boyfriend at a political march. I denied the defendant's motion to dismiss, which argued that the defendant could not be charged with both interfering with a peace officer and resisting arrest under the statute. The Oregon Court of Appeals reversed, agreeing with defendant that the legislature had intended to preclude double charging. The Oregon Supreme Court then reversed the Court of Appeals affirming my judgment.

Lunsford v. NCH Corp., No. 110912644, Dkt. __, (Multnomah Cty. Cir. Ct. June 6, 2013) (copy supplied), aff'd, 351 P.3d 804 (Or. App. 2015), vacated and remanded, 381 P.3d 824 (Or. 2016), aff'd, 396 P.3d 288 (Or. App. 2017). Plaintiff's estate brought a wrongful death products liability suit, alleging death of plaintiff due to exposure to benzene-containing products manufactured by the defendant. I granted a dismissal under ORCP 21 A(9) as time-barred by the statute of ultimate repose for product liability claims. Plaintiff appealed and defendant filed a protective cross-appeal raising the same issue. The Oregon Court of Appeals affirmed on appeal and dismissed the cross-appeal as moot, concluding that the statute of ultimate repose for product liability case does not violate the Oregon Constitution's remedy clause or its jury trial clause. The Oregon Supreme Court vacated and remanded the Court of Appeals decision in light of that court's opinion in Horton v. OHSU, 359 Or. 168, 376 P.3d 998 (2016). In light of Horton, the Court of Appeals affirmed and dismissed the cross-appeal as moot.

Hoddenpyl v. Fiskum, No. 14CV11259, Dkt. ___ (Multnomah Cty. Cir. Ct. Jan. 30, 3015) (copy supplied), *rev'd*, 383 P.3d 432 (Or. App. 2016). The plaintiff brought a personal injury case against another motorist in connection with an automobile

accident. Following entry of default judgment in favor of plaintiff, I denied the defendant's motion to set aside the judgment. The defendant appealed. The Oregon Court of Appeal reversed, holding that defense counsel's negligence in preparing a letter to plaintiff's counsel containing written notice of counsel's intent to file an appearance constituted excusable neglect, as required for relief from the default judgment.

State v. R-Robinson, No. 140230636, Dkt. ____ (Multnomah Cty. Cir. Ct. June 23, 2014) (copy supplied), remanded for resentencing, 369 P.3d 1242 (Or. App. 2016). The defendant was convicted of fourth-degree assault constituting domestic violence, and I sentenced the defendant to five years of probation using his prior Colorado convictions for assault to calculate his criminal history score. The defendant appealed his sentence, arguing that the Colorado statutes did not match the Oregon elements and were insufficient to calculate his criminal history score for sentencing. The State conceded there had been an error, and the Oregon Court of Appeals reversed and remanded for resentencing. At resentencing, I imposed the same probationary period and conditions, but with a different criminal history score. The Oregon Court of Appeals otherwise affirmed my judgment.

State v. Johnson, No. 14CR24944, Dkt ____ (Multnomah County Cir. Ct. Mar. 6, 2015) (copy supplied), *rev'd*, 406 P.3d 139 (Or. App. 2017). The defendant pled no contest to robbery and other crimes. I initially concurred in the written plea agreement that the defendant could be considered for sentence reductions and certain early release programs under Oregon Revised Statute §137.750(1), but then entered an amended judgment providing that the defendant could not be considered for certain early release programs. The defendant appealed. The Oregon Court of Appeals reversed and remanded because I departed from the written plea agreement. On remand, a supplemental judgment was entered providing that the defendant could be considered for certain release programs.

State v. Bradford, No. 131154171, Dkt. ____ (Multnomah Cty. Cir. Ct. Mar. 7, 2014) (copy supplied), *rev'd*, 352 P.3d 1278 (Or. App. 2015). I instructed the jury on defense of premises in a jury trial for fourth-degree assault and harassment. The defendant appealed. The State conceded that my giving of the instruction was error and not harmless. The Oregon Court of Appeals accordingly was reversed and remanded. On remand, the State reported unable to proceed, and the case was dismissed.

State v. Urbaschak, No. 130242497, Dkt. ____ (Multnomah Cty. Cir. Ct. May 31, 2013) (copy supplied), *rev'd*, 342 P.3d 1108 (Or. App. 2015). The defendant appealed his conviction for second-degree criminal mischief, on the ground that I had admitted evidence in violation of the "best evidence" rule. The Oregon Court of Appeals reversed and remanded the case, concluding that the admission of evidence was erroneous and not harmless. On remand, the State reported unable to proceed, and the case was dismissed.

State v. Richards, No. 110933856, Dckt. ____ (Multnomah Cty. Cir. Ct. Nov. 12, 2014) (copy supplied), aff'd in part and rev'd in part, 328 P.3d 710 (Or. App. 2014). During a court trial, I excluded the testimony of witness Galvez. The defendant appealed his convictions. The State conceded that I erred in excluding the testimony, but argued that the error was harmless because I did not have the benefit of all of the available evidence relevant to the defendant's claim of self-defense. The Oregon Court of Appeals affirmed the defendant's menacing conviction, but reversed and remanded on attempted murder, assault in the second degree, and unlawful use of a weapon based on evidentiary error and remanded for resentencing.

State v. Hawkins, No. 090130026, Dkt. (Multnomah Cty. Cir. Ct. Oct. 24, 2014) (copy supplied), aff'd in part and rev'd in part, 323 P.3d 463 (Or. App. 2014), rev den, 333 P.3d 334 (Or. 2014). Following the denial of the defendant's motion to dismiss for lack of a speedy trial, the defendant was convicted of first-degree robbery with a firearm, unlawful use of a weapon with a firearm, and being a felon in possession of a firearm. The defendant appealed, arguing his speedy trial rights were violated and that his motion for judgment of acquittal should have been granted because there was insufficient evidence for the case to proceed. The Court of Appeals affirmed in part, reversed in part, and remanded for resentencing after holding (1) delay of twenty-two months and six days between defendant's indictment and trial was reasonable under the speedy trial statute; (2) the state did not prove firearm element of aggravated crime of first-degree robbery with a firearm; (3) the error in denying defendant's motion for judgment of acquittal (MJOA) on the count for first-degree robbery with a firearm was not harmless; and (4) a conviction for first degree robbery with a firearm was reversed. On remand, a conviction for first degree robbery was entered.

State v. Stewart, No. 091235109, Dkt. (Multnomah Cty. Cir. Ct. Aug. 23, 2010) (copy supplied), aff'd in part and rev'd in part, 314 P.3d 966 (Or. App. 2013). After a court trial, the defendant appealed her six convictions for theft in the first degree, four convictions for making a false claim for health care payment, two convictions for unlawfully obtaining a food stamp benefit, and one conviction for tax evasion. The Oregon Court of Appeals largely affirmed, except that it reversed three of the theft in the first-degree convictions based on insufficient evidence.

State v. Holiday, No. 101051182, Dkt. (Multnomah Cty. Cir. Ct. Jan. 6, 2011) (copy supplied), *rev'd*, 310 P.3d 1149 (Or. App. 2013). A jury found the defendant guilty of unlawful possession of cocaine, after I denied a motion to suppress to suppress a crack pipe discovered after the opening of the door to a locked restroom. The Oregon Court of Appeals reversed and remanded, concluding that the search had been unlawful. On remand, the State reported unable to proceed, and the case was dismissed.

Wilson v. Tri-Cnty Metro. Trans. Dist. of Or., No. 030100495, Dkt. (Multnomah County Cir. Ct. July 28, 2010) (copy supplied), aff'd in part and rev'd in part, 228 P.3d 1225 (Or. App. 2010), rev. den., 237 P.3d 824 (Or. 2010). I granted the plaintiff

attorney fees under Oregon Revised Statute §742.061, but limited them under Oregon Revised Civil Procedures (ORCP) 54E. The plaintiff appealed, alleging that I incorrectly determined that the offer of judgment was exclusive of attorney fees, and that attorney fees should not have been limited. The defendant cross appealed, alleging that I erred in determining that the plaintiff was entitled to attorney's fees. The Oregon Court of Appeals ruled that I should have awarded the plaintiff the full amount of attorney fees requested, but otherwise affirmed my ruling.

State v. Fivecoats, No. 090632530, Dkt. (Multnomah Cty. Cir. Ct. Jan. 11, 2010) (copy supplied), rev'd, 284 P.3d 1225 (Or. App. 2012). During a trial where the primary issue was the identity of a man on a video, the defendant wanted to demonstrate to the jury his gait so it could be compared to the gait of the man in the video. I ruled that the defendant could either exercise his right not to testify or demonstrate his gait to the jury. Thereafter, the defendant was convicted. The defendant appealed. The Oregon Court of Appeals reversed and remanded the case, concluding that I had erred, and the error was not harmless.

Vandeveere-Pratt v. Portland Habilitation Ctr, Inc., No. 080506953, Dkt. _____ (Multnomah County Cir. Ct. July 2, 2009) (copy supplied), *rev'd*, 259 P.3d 9 (Or. App. 2011). In this slip and fall case, the jury decided in favor of the defendants after I refused to give an unreasonably dangerous jury instruction and instead gave a duty to maintain a reasonable lookout jury instruction. The plaintiff appealed, challenging those instructions. The Oregon Court of Appeals reversed and remanded, agreeing that I had erred. On remand, a new trial date was set, but the case settled shortly before trial.

De Bay v. Wild Oats Market, Inc., No. 080406238, Dkt. (Multnomah County Cir. Ct. June 9, 2009) (copy supplied), aff'd in part and rev'd in part, 260 P.3d 700 (Or. App. 2011). I granted the defendants' motions to dismiss the plaintiff's wrongful discharge claim against his former employer, Wild Oats Market, Inc. and two related corporate entities. The defendant appealed, the Oregon Court of Appeals affirmed the dismissal as to two related entities, but reversed and remanded the judgment of dismissal as to Wild Oats Market, Inc.

State v. Romero, No. 070833871, Dkt. (Multnomah County Cir. Ct. Jan. 30, 2008) (copy supplied), rev'd, 237 P.3d 894 (Or. App. 2010). I granted defendant's motion to dismiss the case with prejudice because the State failed to procure a necessary witness. The State appealed, and the Oregon Court of Appeals reversed, concluding that I lacked authority to dismiss the case as a sanction for the State's lack of readiness for trial. On remand, the case was dismissed.

State v. Chambers, No. 060343216, Dkt. (Multnomah County Cir. Ct. Aug. 2, 2006) (copy supplied), *rev'd*, 203 P.3d 337 (Or. App. 2009). I denied the defendant's motion to suppress evidence that the police obtained after stopping him for community caretaking purposes. Following a conditional plea, the defendant appealed, and the Oregon Court of Appeals reversed, concluding there had been no

basis for the search that led to the evidence at issue. On remand, the State reported unable to proceed, and the case was dismissed.

State v. MacDonald, No 08053235, Dkt. ____ (Multnomah County Cir. Ct. July 22, 2008) (copy supplied), rev'd, 222 P.3d 718 (Mem) (Or. App. 2009). I accepted the defendant's guilty plea to five counts of identity theft arising from the defendant's possession of a victim's wallet with various forms of victim's personal identification. The defendant appealed, arguing that the five counts should have been merged into a single conviction. The Oregon Court of Appeals agreed, and reversed and remanded for resentencing.

Marsh v. Am. Fam. Mut. Ins. Co., No. 051213237, Dkt. ____ (Multnomah County Cir. Ct. Mar. 8, 2007) (copy supplied), rev'd, 218 P.3d 573 (Or. App. 2009). The defendant insurer filed a motion for entry of judgment in its favor on the ground that the plaintiff insured's homeowners insurance policy did not provide coverage for dry rot in a bathroom as claimed by the plaintiff. I denied the motion, concluding that while an exclusion barred coverage under the main part of the policy, there was coverage under the policy's supplemental coverage provision, though that the amount of coverage was limited to \$5,000. I entered judgment for the plaintiff in the amount of \$5,000 plus attorney's fees. The defendant appealed, and the Oregon Court of Appeals reversed, concluding that, although I correctly ruled there was not coverage under the main policy, I erred in ruling there was coverage under the supplemental coverage provision.

Ransum v. Woldridge, No. 06F014061, Dkt. ____ (Multnomah County Cir. Ct. Oct. 3, 2006) (copy supplied), *rev'd*, 192 P.3d 851 (Or. App. 2008). I granted the plaintiff's Forcible Entry and Detainer (FED) judgments against the defendant's sailboats and entered supplemental judgments for costs and disbursements, concluding that the Residential Landlord and Tenant Act (RLTA) did not apply because, based on how they were used, the sailboats were not dwelling units. The defendant appealed, and the Oregon Court of Appeals reversed, concluding that because of how the sailboats were used, they were considered dwelling units under the RLTA and the length of time for the notice of eviction was insufficient.

State v. Adams, No. 051137002, Dckt. ____ (Multnomah County Cir. Ct. June 7, 2006) (copy supplied), rev'd, 185 P.3d 570 (Or. App. 2008). I denied the defendant's motion to suppress evidence that the police obtained after stopping him. The defendant appealed, and the State conceded that the police lacked reasonable suspicion for the stop, and so the evidence should have been suppressed. The Oregon Court of Appeals accordingly reversed and remanded. On remand, the State reported unable to proceed, and the case was dismissed.

As an Associate Justice of the Oregon Supreme Court, all of my decisions are published. As a Multnomah County Circuit Court Judge, most of my decisions were issued from the bench in open court and recorded in the reporter's transcript or in a minute order, and all of my opinions were unpublished. The Multnomah County Circuit Court does not maintain any readily accessible database of my decisions. Rather, the case files are stored in the Multnomah County Circuit Court's case management system.

Oregon Revised Statute (ORS) §14.260 allows for any party or attorney in an action to file a peremptory challenge against a judicial officer. Although the party or attorney must attest that the party or attorney believes that the party or attorney cannot have a fair and impartial trial or hearing before the judge, no specific grounds need be provided, and a copy of the motion is typically not provided to the judge in question. As best I can determine, I received only 15 disqualification motions under §14.260 in the course of my 12-year career as a Multnomah County Circuit Judge, and I have not had any requested recusals as an Oregon Supreme Court justice.

ORS §14.210 also requires a judge to recuse for cause. I never recused myself sua sponte, but I was asked to recuse myself under §14.210 in the following two cases:

Stephen v. Vangelisti Kocher LLP et al., Multnomah County Circuit Court No. 1008-11800 (Multnomah Cty Cir. Ct.). The plaintiff in this case filed a complaint against me with the Oregon Judicial Fitness Commission, alleging that I had conspired with the defendant and their counsel. To my best of my knowledge, the Commission took no action. At our next scheduled court proceeding, I stated on the record that I was aware of the complaint and that I would not recuse myself because I could be fair and impartial. I continued to preside over the case to its conclusion. The plaintiff subsequently filed a federal lawsuit against me, the Oregon Judicial Department, Department employees, the defendant, and their counsel. In *Stephens v. Multnomah County et al.*, No. 3:12-CV-00171-MO, 2012 WL 2921360 (D. Or. July 13, 2012), the United States District Court for the District of Oregon dismissed the lawsuit with prejudice. The plaintiff and her husband appealed. In *Stephens v. Multnomah County by and through Judicial Department*, 678 F. App'x 517 (9th Cir. 2017), the United States Court of Appeals for the Ninth Circuit affirmed.

State v. Voight, No. 040343287 (Multnomah Cty Cir Ct), I presided over a bench trial in which Mr. Voight was convicted of a number of charges. I then became the probation judge. In August 2016, Mr. Voight asked me to recuse myself during a probation violation hearing on the ground that I had a connection to the victim through prior employment. I initially denied the request, concluding I could be fair and impartial and there was no basis for recusal. Later in the case, I received verified information that Mr. Voight had been following me around in disguise over a period of months to substantiate

his mistaken belief that I was connected to the victim and her place of employment. Upon receipt of that information, I recused myself, the case was reassigned to another judge to handle Mr. Voight's probation violation hearing. I continued to the probation judge for the remainder of probation with no other interaction.

As a Coordinator & Senior Attorney for Portland State University Legal and Mediation Services, I served as a mediator in two family law cases in 2005. One case involved the division of property and the other involved the custody and visitation. From 2008 to 2013, I also served as a member of the Multnomah County Civil Case Management Committee. As part of the Committee, I helped develop and implement Multnomah County's expedited civil trial system, which helped bolster the efficiency and fairness of the Multnomah County Circuit Court.

Additionally, in 2012, I spent five months as the Presiding Judge of the Multnomah County Circuit Court Mental Health Court. To be eligible for the Program, defendants must have a particular type of mental health diagnosis and be charged with certain offenses.
