Re: Nomination of Mia Roberts Perez to the United States District Court for the Eastern District of Pennsylvania

Dear Chairman Durbin and Ranking Member Grassley:

We write to offer our strongest and most enthusiastic support for the confirmation of Mia Perez to the United States District Court for the Eastern District of Pennsylvania.

We are criminal defense attorneys who practice in Philadelphia, Pennsylvania. The vast majority of us have appeared in front of Mia Perez for the whole of her tenure on the bench of the Court of Common Pleas in Philadelphia County. Moreover, many of us are former colleagues of hers from her time at the Defender Association of Philadelphia and while she was a private practitioner. Some of us are also former prosecutors. Bruce Franzel was her professor for Trial Advocacy at Temple Law School, and has watched her progress and success as both a lawyer and a judge with a great sense of pride.

From the beginning of her legal career to her time on the bench, Mia Perez has proven herself to have a high intellect, a strong work ethic, and an innate sense of fairness. She has always been an approachable and grounded person, which did not change upon becoming a judge. In her courtroom, she treats everyone with respect and listens to all sides with an open mind. Prior to becoming a judge, Mia Perez was a talented trial lawyer, having tried hundreds of cases to verdict, often a winning verdict, in both state and federal courts. At the Defender Association of Philadelphia, one of the most distinguished defender offices in the country, she was one of the first of her starting class to transition, based on merit, from unit to unit. She prepared, litigated, or resolved thousands of misdemeanor cases, and hundreds of felony bench trials, juvenile delinquency cases, and major felony jury trial cases. She has a breadth of trial experience both as a litigator and a jurist that will lend itself well as a District Court Judge.

Mia Perez has always been a dedicated public servant as both a public defender and a judge, however, even when she was in private practice that dedication remained as she served both as court-appointed counsel in Philadelphia County, and as a member of the Criminal Justice Act (CJA) Panel for the District Court of the Eastern District of Pennsylvania.

In short, we all believe that Mia Perez possesses the knowledge, intelligence, experience, work ethic, and impartiality required of a District Court Judge, and give her our strongest endorsement.
