A "Highly Recommended" rating is reserved for only the most exceptional candidates and requires at least 90% of the Commission's 33 members to vote in favor.

A Philadelphia native and a graduate of Hampton University and the University of West Virginia College of Law, Judge Scott previously served as a public defender for six years and then served for 11 years as a federal defender, providing counsel to clients with limited financial resources. Judge Scott is a valued colleague, mentor and friend in our community. She continually strives to improve Philadelphia's judicial system and to increase equal access to justice within our City and in the Commonwealth.


