Re: Letter in support of Nancy Abudu, nominee for the United States Court of Appeals for the Eleventh Circuit

Dear Chairman Durbin and Ranking Member Grassley:

I am thrilled and honored to write this letter in support of Ms. Nancy Abudu's nomination to the United States Court of Appeals for the Eleventh Circuit. I have known of Ms. Abudu's professional reputation for several years and observed her legal skills closely for the past five years. Based on this knowledge, my observations, and my decades of working with law students, lawyers, and judges, I have complete confidence that Ms. Abudu has all the attributes necessary to serve on our federal appellate court with distinction. She has the judgment, impartiality, and the respect for the rule of law that every judge must hold to do the job properly. It has been my privilege and honor to teach and prepare future lawyers for over thirty-five years. For the past thirty-one years, I have served as Constitutional scholar and professor at The University of Alabama School of Law. I have taught, observed, and evaluated tens of thousands of law students, recommending many of them for professional opportunities, including judicial posts.

In my estimation, Ms. Abudu embodies all the traits of an exemplary jurist. Anyone who meets her immediately recognizes that she is exceptionally bright, talented, and intellectually curious. Her formative training at Columbia and Tulane prepared her to become an effective legal advocate for her clients. She is a seasoned litigator with broad experience in federal and state courts, including the federal circuit courts and the United States Supreme Court. She worked for a large, international law firm and she was a young staff attorney for the Eleventh Circuit, before taking her talents to several national nonprofit organizations to protect civil liberties and civil rights. Ms. Abudu has an outstanding professional reputation and an exceptional rating as a lawyer. I have observed her as a case manager and advocate. We have regularly discussed legal questions and Ms. Abudu has a sophisticated command of the law and a brilliant mind. Her legal writing is precise and persuasive. Ms. Abudu has the personal and professional ethics to serve on the court with honor and integrity. Raised primarily by her father, she is a first-generation, Ghanaian-American attorney. He taught her to care about the rights of others and to reject discriminatory practices whether based on gender, race, class, or some other ground. Ms. Abudu is a devoted mother of two teenage daughters. Raising them and watching them thrive has been one of the greatest joys of her life. The values and principles she developed through her upbringing and family inspired Ms. Abudu to work tirelessly to promote fairness and due process for all under the law and fidelity to the law. She has represented a broad array of clients presenting diverse legal questions in courts across the country. She has broad experience with constitutional litigation in areas such a religious liberty, freedom of expression, and voting rights, among others. I have observed firsthand Ms. Abudu work week after week, and year after year, to plan and prepare cases for trial and argument. She doesn't take shortcuts. She does whatever is needed to best prepare for every matter. Without reservation, I can attest that Ms. Abudu has unimpeachable ethical standards; she will be a fair-minded jurist; and she will bring that same work ethic to the bench.

In addition to her talent, skill, and ethics, Ms. Abudu is a wonderful person. She cares about all people, including the most vulnerable. She works well with others, including opposing counsel. Ms. Abudu is well respected by the bar and the bench. Her grace and patience will allow her to work with colleagues on the court and with all the parties presenting matters before it.

I am confident Ms. Abudu will be an effective jurist and that she will perform her duties exceptionally well. I endorse her nomination without any reservation. For all the reasons stated above, I hope you will support her nomination as well.
