I have served as an Associate Justice on the Vermont Supreme Court since November 2011. I was appointed by Governor Peter Shumlin following a merit screening process by the Vermont Judicial Nominating Board. The Vermont Supreme Court has jurisdiction over appeals from the civil, probate, family, criminal, and environmental divisions of the superior court, as well as appeals from state agencies such as the Human Services Board, the Employment Security Board, and the Public Utilities Commission.

a. Approximately how many cases have you presided over that have gone to verdict or judgment?

I estimate that I have participated in approximately 1,750 decisions during my time on the Vermont Supreme Court, not counting the significant number of cases that are dismissed prior to argument on the basis of the parties' stipulation, a failure to make required filings, untimely filing, or for similar reasons.

I have only "presided" over four cases in which I was specially designated to sit on the superior court, as well as over certain bail appeals that are resolved by a single justice. Occasionally, when the Chief Justice is absent or not on a threejustice panel, I "preside," in the sense that I am the most senior justice on the bench for that argument.

Ninety-nine percent of the cases I have participated in are appellate cases. I have sat as a trial judge by special designation for four

contested hearings (bench trials). Three were divorce cases, and the fourth was a termination-of-parental-rights case. Additionally, I was the trier-of-fact in a "de novo" appeal of a hold-without-bail order. With the exception of those cases, all of the matters I have participated in as a judge have been appeals.

I have not generally "presided" over cases in the sense this term usually connotes. I have identified ten representative cases that I participated in, other than cases in which I wrote an opinion.

1. State v. Medina, 2014 VT 69, 197 Vt. 63, 102 A.3d 661

In this case, the Vermont Supreme Court considered the constitutionality under the Vermont Constitution of a statute requiring individuals arraigned on felony charges to provide DNA samples after a determination of probable cause and prior to any conviction. The trial court held the statute unconstitutional, and we affirmed. The Court acknowledged that the intrusion serves a special need beyond the normal needs of law enforcement such that an exception to the general warrant requirement may apply. But balancing the government's interest in getting the DNA evidence post-arraignment as opposed to post-conviction against the heightened privacy interests of an individual who has been arraigned but not yet convicted of a felony, we concluded that the statute violated Article 11 of the Vermont Constitution. Chief Justice Reiber, joined by Justice Burgess, dissented.

2. Demag v. Better Power Equipment, Inc., 2014 VT 78, 197 Vt. 176, 102 A.3d 1101

In this premises-liability decision, the Vermont Supreme Court abrogated the common law distinction between the duty owed to invitees versus licensees. The evidence in the summary judgment record, viewed in the light most favorable to the plaintiff, was that the plaintiff, who worked for a car dealership, drove to the defendant establishment to pick up the general manager's car to take it in for service. While in the defendant's parking lot, the plaintiff stepped in an open storm drain and suffered injuries. The trial court granted the defendant summary judgment on the basis that the plaintiff had failed to establish that the defendant violated the more modest standard of care applicable to licensees as opposed to invitees. On appeal, in a decision authored by Justice Dooley, we abolished the invitee-licensee distinction and established a single standard of reasonable care for both. We thus reversed and remanded the case for further proceedings.

3. State v. Putnam, 2015 VT 113, 200 Vt. 257, 130 A.3d 836

This case gave the Court the opportunity to establish clearer parameters for the imposition by trial courts of probation conditions. After his conviction for disorderly conduct and grossly negligent operation of a motor vehicle, the defendant challenged his conviction and various conditions of probation. We affirmed the conviction. The case is more significant for its discussion of the probation conditions. We ruled that the list of conditions on court-generated

probation-condition forms, which were often colloquially described as "standard conditions," are not "standard" in any meaningful sense. We specifically required that probation conditions must be reasonably related to the crime for which an offender was convicted, and struck several of the imposed probation conditions on the basis that they were not sufficiently connected to the defendant's offense or specific circumstances. We also held that probation conditions may not unlawfully delegate to probation officers the authority to make determinations that should be made by the court, and we struck a condition on that basis. Justice Skoglund, joined by Judge Maley, specially assigned, dissented only as to a probation condition requiring payment of public defender fees.

4. AIG Ins. Mgmt. Servs., Inc. v. Vt. Dep't of Taxes, 2015 VT 137, 201 Vt. 9, 134 A.3d 1232

The question in this case was whether a taxpayer's subsidiary was part of the taxpayer's "unitary group," such that the apportioned share of income earned by the taxpayer out of state could be taxed in Vermont. AIG Insurance Management Services, Inc. ("AIG") owned a subsidiary, Mount Mansfield Company, Inc. ("MMC") that ran a ski resort in Vermont. The Vermont Department of Taxes concluded that AIG and MMC were a unitary enterprise, such that the State of Vermont could assess a tax for an allocable share of the combined net income of the group. The trial court reversed the Department's decision. We concluded that even though AIG had sole ownership and the ability to direct MMC's operations, MMC was a distinct business operation. There was insufficient evidence of economic interdependence between the operations to support Vermont's taxing a portion of AIG's out of state operations. We accordingly affirmed the trial court's reversal of the Department's decision.

5. State v. Sawyer, 2018 VT 43, 207 Vt. 636, 187 A.3d 377

This case called upon the Vermont Supreme Court to determine whether the State had presented sufficient evidence to support a charge of attempted murder against a would-be school shooter. The defendant allegedly maintained a journal captioned "The Journal of an Active Shooter," acquired a shotgun and some magazines, and made threats against his former high school in social media messages. The defendant also allegedly admitted to police offers that he had been plotting a school shooting, describing his specific plans for conducting the shooting as well as steps he had taken to advance his plan. Based on this and other evidence, the State charged the defendant with three counts of attempted murder. The trial court ordered the defendant held without bail, and the defendant appealed that order. The court's authority to hold the defendant without bail flowed from the validity of the three charges of attempted murder, so the primary issue in the appeal was whether the evidence cited by the State could support any such charge. In a *per curiam* decision, a three-justice panel reviewed our case law on attempt and concluded that in order to constitute an attempt to commit a crime, the act must "reach far enough towards the accomplishment of the desired result to amount to the commencement of the consummation." We held that the State's evidence in this case did not meet that standard and reversed the order holding the defendant without bail.

6. State v. Lizotte, 2018 VT 92, 208 Vt. 240, 197 A.3d 362

In this case, the Vermont Supreme Court considered whether the defendant's Fourth Amendment rights were violated when his online service provider, AOL, searched his transmissions, detected suspected child pornography, and sent information to the National Center for Missing and Exploited Children (NCMEC), which opened the email and attachment and provided it to Vermont law enforcement. The trial court denied the defendant's motion to suppress evidence seized from his home pursuant to a search warrant that was, in turn, based on the content of the email and attachment. We reviewed the ruling following the defendant's conditional guilty plea. We concluded that-even assuming the defendant had an expectation of privacy in his digital communications, because AOL was not acting as an agent of law enforcement when it subjected his digital communications to its automated search technology-its actions did not raise Fourth Amendment concerns. NCMEC, by contrast, was acting as an agent of law enforcement when it opened the defendant's email and the related attachment. NCMEC's opening the video file that was identified by AOL was not an expansion of the search conducted by AOL, but its opening the email to which the video file was attached was an expansion of AOL's private search. We did not invalidate the search warrant, however, because even without the information from the body of the email, the affidavit in support of the warrant established probable cause. We thus affirmed the trial court's denial of the motion to suppress and, in turn, the defendant's conviction.

7. State v. VanBuren, 2018 VT 95, 210 Vt. 293, 214 A.3d 791

This was the first case in which a state supreme court considered the constitutionality of a statute criminalizing nonconsensual pornography. Here, the complainant sent nude photos of herself to the defendant's boyfriend through private messaging, and the defendant allegedly access her boyfriend's account

without authorization, saw the pictures of the complainant, and posted and tagged the pictures on social media in order to "ruin complainant and get revenge." The parties stipulated that the complainant and the defendant's boyfriend were not in a relationship at the time the complainant sent the images to the boyfriend. The trial court concluded that the statute criminalizing nonconsensual pornography was unconstitutional on its face under the First Amendment to the United States Constitution because it violated the right to free speech, and it dismissed the State's charges.

On appeal, the Vermont Supreme Court held that the statute, construed narrowly, was not unconstitutional. We concluded that the statute, with a narrowing construction, survived strict scrutiny because it was narrowly tailored to serve a compelling state interest. We concluded, however, that the State had not established a *prima facie* violation of the statute in this case. Given the State's stipulation that the complainant was not in a relationship with the defendant's boyfriend when she sent the nude photos, we concluded that the State could not show that she had a reasonable expectation of privacy in the images—an essential element of the State's case.

8. Zullo v. State, 2019 VT 1, 209 Vt. 298, 205 A.3d 466

The plaintiff sued the State of Vermont for damages arising from various alleged violations of his state constitutional rights following a roadside stop and seizure of his car. The superior court granted the State's motion for summary judgment on the basis that the trooper's actions did not violate the Vermont Constitution. On appeal, we concluded that the common law doctrine of sovereign immunity was not a jurisdictional bar to the plaintiff's civil damage suit against the State alleging that a state officer deprived him of the protection from governmental interference guaranteed by Article 11 of the Vermont Constitution, and we held that plaintiff had an implied right of action directly under Article 11 subject to a limitation akin to qualified immunity. On the merits of the plaintiff's substantive claims, we concluded that the stop was unlawful because there was no reasonable

basis in the law for concluding that snow obscuring part of the registration sticker on a license plate was unlawful. We concluded that given the faint odor of burnt marijuana the trooper detected, as well as the redness of the plaintiff's eyes, the trooper had reasonable suspicion for his exit order so he could determine whether the plaintiff was driving impaired. At the same time, however, we concluded that the officer did not have probable cause to seize the plaintiff's car for the purpose of requesting a search warrant. We remanded the case for further proceedings.

9. Athens Sch. Dist. v. Vt. State Bd. of Educ., 2020 VT 52, ___ Vt. __, 237 A.3d 671

This case involved statutory and state constitutional challenges to the Board of Education's implementation of a law compelling various school districts to merge into neighboring districts. The trial court granted summary judgment to the defendant Board of Education. On appeal, we upheld the law and the Department of Education's implementation of it. We concluded that the law did not require the Board or Agency of Education to make an explicit finding that a proposed merger of school districts was "necessary" before requiring a merger, that the Department's and Board's implementation of the law was consistent with the law itself and other statutes, and that the law did not unlawfully delegate legislative authority or violate any other constitutional provisions. We thus affirmed the trial court's judgment.

10. State v. Misch, 2021 VT 10, Vt. A.3d , 2021 WL 650366

This case involved a challenge under the Vermont Constitution to a statute prohibiting possession of large capacity magazines. A defendant was charged with violating the statute, and the Vermont Supreme Court accepted interlocutory review to assess the constitutionality of the statute under the Vermont Constitution. In a *per curiam* decision, the Court upheld the law under the Vermont Constitution. We concluded that the right to bear arms in the Vermont Constitution includes a right that is independent of service in a state militia, and is tied to the defense of self, family, and home. We followed the majority of our sister states in adopting a "reasonable-regulation" test, and concluded based on the available evidence that the large-capacity magazine restriction was constitutional under that test. The defendant charged with violating the law did not raise a federal constitutional challenge. Because we concluded that the law was constitutional under the Vermont Constitution, we remanded the case for further proceedings.

I have not participated in any decisions that have been reversed by the United States Supreme Court, or that have been affirmed with significant criticism. To my knowledge, none of the cases on which I sat by special designation as a trial judge were appealed.

I have issued one ruling that has been reversed on appeal. The Vermont Legislature has authorized courts to hold a defendant charged with a felony, an element of which involves an act of violence against another person, without bail if the court finds that (i) the evidence of guilt is "great," (ii) the defendant's release presents a substantial risk of physical violence to a person, and (iii) no condition or combination of conditions would reasonably prevent the physical violence. A defendant's avenue of appeal from an adverse hold-without-bail decision pursuant to this statute is to a single justice of the Vermont Supreme Court, who is required to hold a *de novo* hearing sitting as a trier-of-fact. I conducted one such hearing. The most significant issue in the case involved a statutory provision that requires the court to hold the trial within 60 days, or to set bail if it fails to do so. The question was whether the 60 days began to run at the time the defendant was first held without bail pending a hearing, or at the time the court issued its order holding the defendant pursuant to the statute. I concluded that, "regardless of how compelling defendant's arguments may be," I was bound by a prior published opinion of a single justice to hold that the "clock" started running only after the court's hold-without-bail decision, and that the defendant's recourse was to appeal my ruling on this subject to a three-justice panel of the Supreme Court. The defendant did so, and the Vermont Supreme Court, which was not bound by the prior precedent that I had concluded constrained my own analysis, overruled the prior precedent and accordingly reversed my decision on the matter. State v. Downing, 2020 VT 97, Vt. , 245 A.3d 758, rev'd, 2020 VT 101, Vt., 247 A.3d 150.

All five-justice opinions in Vermont issued after argument are published and available on the Vermont Judiciary's website at ttps://www.vermontjudiciary.org/supreme-court/published-opinions-and-entry-

orders, as well as through independent services such as Westlaw. In the year from July 1, 2018 through June 30, 2019, for example, of all cases resolved by a decision of the Court (rather than closed by stipulation, for lack of progress, or due to the appellant's withdrawal) approximately 50 percent, or about 120 cases, were resolved by a published written five-justice opinion.

Approximately three percent, or seven cases, were resolved by published fivejustice entry order. These decisions are issued *per curiam*, and are generally published. Moreover, decisions that are not formally designated for publication in the Vermont Reports, but that include significant legal analysis, are posted on the Vermont Judiciary's website and generally published by commercial legal research databases such as Westlaw. The decision to post unpublished fivejustice entry orders online is made by Judiciary staff.

Five-justice entry orders resolving motions that require five justices (such as stipulations to dismiss an appeal and some non-dispositive motions) are usually unpublished, although we occasionally designate a five-justice entry order for publication if it resolves legal questions with broader application. Further, even if we do not designate a five-justice entry order for publication, if Judiciary staff concludes that the order includes substantive legal analysis of potentially broader interest, the orders may be posted on the Judiciary website and, in turn, published by commercial legal research databases.

Three-justice decisions in cases decided through summary procedures are unpublished. These opinions are all issued *per curiam*. Although they are designated "unpublished," the opinions are available on the Vermont Judiciary website at https://www.vermontjudiciary.org/supreme-court/unpublished-entryorders and many of them are also available through commercial legal research databases. In the year from July 1, 2018 through June 30, 2019, of the cases that were resolved by a decision of the Court, approximately 47 percent, or 114, were resolved by an unpublished three-justice entry order. I participated in approximately 60 percent of all three-justice cases.

Three-justice opinions in those bail appeals that are subject to three-justice review are generally published and are available on the Vermont Judiciary site as well as through online services.

Single-justice opinions in connection with bail appeals that are subject to singlejustice review may be denominated "published" or "unpublished." Regardless of whether they are reported in the Vermont Reports, the opinions are posted on the Judiciary website and in turn, published by commercial legal research databases. The list of cases at Q13b includes the nine single-justice unpublished entry orders I have issued while on the court.

Single-justice decisions granting or denying non-dispositive motions are unpublished. These include routine motions to file a brief in excess of the word limit, motions to continue argument, motions to strike matters from the record, and other procedural matters. These rulings are considered public records, except in cases that are confidential (such as juvenile cases), but they are not posted on any publicly accessible web sites.

The longstanding practice on the Vermont Supreme Court has been to not disclose the basis for an individual justice's decision to recuse from a particular case. My general practice has been as follows. For my first few years on the Court, I reviewed the list of new cases every few weeks to identify potential conflicts. Now, because I have so many fewer conflicts, I review cases for conflicts as I am preparing for oral argument. If I identify a matter that creates a conflict pursuant to the rules, or a potential appearance of impropriety that causes me to recuse as a matter of discretion, I notify the staff person who manages our court calendar, and she arranges a substitute judge to sit by special assignment. In some cases, if I conclude that my participation could raise a potential appearance of impropriety, but not one that would necessarily lead me to recuse myself, I give notice to the parties of the potential concern so they can file a motion if they choose. In some cases, the potential conflict has not become apparent to me until oral argument, in which case I have not participated in the case conference or decision.

With respect to the substance of my recusal decisions, I have recused when I have a conflict under the rules, or when faced with a potential appearance of conflict. Several considerations have driven my recusal decisions.

For a period of two years from the time my former law firm completed legal work for me, I automatically recused from cases in which Langrock Sperry & Wool represented the client on appeal. For a period after that, I formally disclosed my prior affiliation with the firm both as a partner and as a client but did not automatically recuse. I have continued to automatically recuse in cases in which Langrock Sperry & Wool represented a party in the same matter during the period I was still affiliated with the firm. In recent months, I have begun automatically recusing from all Langrock Sperry & Wool cases again because I have retained an attorney there to do legal work.

In addition, I have recused myself from cases involving legal questions with respect to which I took a position in the Vermont Legislature on behalf of the Governor, cases involving the State that relate to matters that I worked on or was aware of while serving as Governor's Counsel, and cases involving challenges to bar admission decisions arising from the time when I served on the Vermont Board of Bar Examiners.

I have recused myself from cases in which I or my spouse had a personal interest, or a relationship with an individual with a personal stake in the outcome of the case.

Finally, I have recused myself when a party was represented by a lawyer who represented me, my spouse, or my spouse's business contemporaneously or within two years, in cases in which the conduct of a lawyer with whom I have a significant personal relationship has been a material issue in the case, and in cases in which one of several former law partners represents a party in the case.

The Vermont Supreme Court's current case management system does not track recusals. I have used a number of methods to try to identify cases in which I recused, but it is possible that I have missed some. I have not included cases in which I may have recused but was not assigned to the panel to hear a case in the ordinary course, and may not have captured cases that were dismissed before a three-justice or full court decision issued.

i. the general character of your law practice and indicate by date when its character has changed over the years.

I worked at the Washington, DC, office of Skadden, Arps, Slate, Meagher & Flom from the fall of 1990 to the end of the summer of 1991. While there, I worked in the white-collar criminal defense group. I worked primarily on two cases through the entire year, one involving an investigation of our client for alleged corporate sabotage, and one involving allegations that our individual clients were complicit in

violations of federal banking laws. I did legal research and writing, witness interviews, and document review.

In 1992, I did not formally practice law, but I did legal research and writing primarily for Hirschkop & Associates in Alexandria, Virginia. I worked on a range of matters, primarily for a non-profit organization focused on animal rights.

For the next 18 years, from 1993 through 2010, I was an associate, and then a partner, at Langrock Sperry & Wool, a law firm in Middlebury and Burlington, Vermont. For the first decade at Langrock, my primary areas of practice were domestic relations and civil litigation, although I had a varied practice that included a substantial amount of time advising clients about a range of other matters, including employment issues, conflicts with neighbors, and contract disputes. In addition, I briefed and argued a number of appeals (including one significant appeal of a criminal conviction), and developed a practice representing lesbian, gay, bisexual, and transgender clients in connection with civil rights, family law issues, estate planning, and other matters, including litigation to secure access to civil marriage for same-sex couples.

As my practice evolved in the late 1990s and into the 2000s, I developed a greater concentration in the field of workers' compensation. I usually represented injured workers, although occasionally worked for uninsured employers defending workers' compensation claims. Through that same period, I began representing more clients in negligence cases in (and outside of) superior court, and my employment-law practice grew. I also had the opportunity to work with colleagues on larger-scale litigation, such as a suit involving properties with PCB contamination in Pittsfield, Massachusetts.

Throughout this time, I practiced in a host of other areas as well, such as unemployment insurance matters (representing both claimants and employers), probate court proceedings, public accommodations discrimination cases, labor negotiations, and advice for small businesses. I also provided complex legal and strategic analysis for clients advocating or opposing broad policy change with constitutional implications.

From January 7 through November 28, 2011, I served as Counsel to the Governor of the State of Vermont. As the only lawyer in the Governor's office, I dealt with a wide range of legal issues in a fast-paced working environment. My work included (1) providing frequent advice to cabinet members, counsel from other agencies, and the Governor's staff concerning conflicts of interest and ethical requirements; (2) reviewing all legal documents signed by the Governor, from requests for disaster declarations to approvals for bond issues and extradition warrants;

(3) providing close and ongoing coordination with the Vermont Attorney General's office concerning matters in which the Governor was interested;
(4) drafting legislation, testifying before legislative committees, and reviewing bills passed by the General Assembly; and (5) providing legal advice to the Governor, cabinet members, and the Governor's staff on a wide assortment of issues ranging from telecommunications to state and federal powers, and from labor law to agency appointment processes.

From 1993 through 2010, I represented a range of clients. My single biggest cohort of clients consisted of workers injured in the course of their work. These clients included blue collar workers, nurses, tech-industry manufacturing workers, sales representatives, and administrative professionals. In my family law work, I did not typically represent clients in high-asset divorces; most of my family-law work was for ordinary working Vermonters from a host of backgrounds. Finally, I represented a substantial number of lesbian, gay, bisexual, and transgender Vermonters from around the state and a host of backgrounds.

In 2011, when I served as Counsel to the Governor of Vermont, my only client was the Office of the Governor.

From 1993 through 2010, I estimate that 90 percent of my practice involved litigation. The non-litigation aspects of my pre-2011 practice included advice to individuals and businesses on various issues, labor negotiations, contract negotiations or reviews, and estate planning.

The most significant legal activity I pursued before I was appointed to the Vermont Supreme Court was advocating for the freedom to marry for same-sex couples in Vermont. This activity encompassed grassroots organizing and public education efforts, a lawsuit litigated through resolution by the Vermont Supreme Court, intensive legislative advocacy in 2000 culminating in passage of Vermont's civil union law, ongoing grassroots organizing and public education, and another intensive period of legislative advocacy in 2009. Because I did not receive compensation from any client for this work, I was not a registered lobbyist at the time.

As Counsel to the Governor of Vermont, I worked at the intersection of law, policy, and politics. My duties included counseling the Governor and representing the Governor in the legislature, advising the Governor, members of his staff, and others in his administration about ethical issues and a wide range of legal matters, from administrative to statutory to constitutional.

In private practice, I also worked on a variety of significant legal activities. For instance, I advised clients seeking global advice synthesizing constitutional analysis, political assessment, and strategic advice to advance them toward their advocacy goals. A significant portion of my law practice (approximately 30 percent) involved personal injury litigation. In all my years in practice, only one of the personal injury cases on which I was lead counsel went to trial; as a consequence, this work is not represented on the above list of fully litigated cases. I represented nearly a dozen plaintiffs whose cases

involved injuries allegedly incurred as a result of others' negligence while skiing or snowboarding.

Finally, throughout my legal career, I have been involved in a host of matters, both litigated and not, that influenced the development of the law in Vermont relating to lesbian, gay, bisexual, and transgender individuals. In particular:

I successfully represented an employee of the University of Vermont who sought recognition by his employer for health insurance purposes of his Canadian marriage to his partner. As a result of our efforts, the University of Vermont changed its policy.

I successfully represented a couple seeking recognition by a Vermont probate court of their out-of-state marriage for purposes of second-parent adoption (before Vermont allowed same-sex couples to marry).

With co-counsel, I successfully represented a surviving partner seeking Social Security survivor benefits for her child on account of her civil union partner's death where the Social Security Administration initially declined to recognize the parent-child relationship because it was predicated on a civil union.

Gay & Lesbian Advocates & Defenders and I represented a transgender client who had been terminated from his job on account of his transgender status. As a result of our efforts, the Vermont Attorney General for the first time concluded that such discrimination was prohibited by Vermont's then-existing nondiscrimination laws (before gender identity was expressly added to those laws).

I represented a transgender patient who faced an uneven playing field with respect to hospital charges for uninsured transition-related expenses in a matter that led to the hospital's formally adopting a new policy to ensure that transgender individuals are treated equally for hospital-charging purposes.

I may own stocks in companies that are parties to litigation in the Second Circuit. In light of Canon 4(D)(3) of the Code of Conduct for United States Judges, as soon as reasonably possible "without serious financial detriment," I would divest investments that might require frequent disqualification. Before sitting on a case, I would also consider whether I have potential conflicts based on, among other things, my relationship with parties or counsel and my past work at Langrock Sperry & Wool and the Vermont Governor's office. Given that only a small portion of appeals to the Second Circuit come from the District of Vermont, and the number of years I have been on the bench, I expect conflicts to be rare. b. Explain how you will resolve any potential conflict of interest, including the procedure you will follow in determining these areas of concern.

If confirmed, I would address any actual or potential conflicts of interest by applying the Code of Conduct for United States Judges and any other relevant ethical canons or rules.

25. **Pro Bono Work**: An ethical consideration under Canon 2 of the American Bar Association's Code of Professional Responsibility calls for "every lawyer, regardless of professional prominence or professional workload, to find some time to participate in serving the disadvantaged." Describe what you have done to fulfill these responsibilities, listing specific instances and the amount of time devoted to each.

During my time on the Vermont Supreme Court, I have focused on access to justice issues. For example, as part of my administrative responsibilities, I have been particularly involved in efforts to improve judiciary services for self-represented litigants through more expansive online information and guided interviews. Through the Access to Justice Coalition, I have also been part of collaborative endeavors involving Vermont's legal services organizations, the Vermont Bar Association, and the court system.

In private practice, I spent an average of two hours each week taking calls from would-be clients who could not afford a lawyer. Rather than simply turn the individuals away, my practice was to talk or meet with them to educate or advise them about their options. These matters ran the gamut from family law matters to employment issues and from contract disputes to conflicts among neighbors.

At any given time, I tried to carry several cases that were either pure pro bono or, more commonly, were cases that I knowingly took at a financial loss. For example, most recently before I left private practice, on a pro bono basis, I represented a surviving spouse with few assets in a probate court conflict with the adult children of her deceased spouse relating to their mobile home and other assets of the decedent. Around the same time, I also represented a foreign national with no assets in a family law matter; the representation was partly funded through Violence Against Women Act funds due to allegations of domestic violence, but those funds only covered a small portion of the costs of representation.

In addition, throughout my career, I represented LGBT clients pro bono in matters that had broader ramifications for LGBT civil rights. The *Baker v. State of Vermont* case is the most obvious example, and I committed many hundreds of hours to that case. But I have also represented without charge a host of other clients in this category, including the cases noted above involving: an individual seeking recognition of his marriage for health insurance purposes; a couple seeking recognition by Vermont's probate courts of their out-of-state marriage; a surviving partner seeking Social Security survivor benefits for her child; and a transgender client facing obstacles to health care access. In addition, from 2001 to 2010, I spent unbilled time talking with hundreds of people with legal questions about their rights—most commonly out-of-staters who had joined in civil union in Vermont and then broken up, but also Vermonters trying to sort out issues involving different jurisdictions, or seeking answers to questions about the implications of Vermont's civil union law or of legally marrying when that became an option.

In mid-March 2021, Senator Patrick Leahy's State Director contacted me regarding the Second Circuit vacancy left by the Honorable Peter Hall. In mid-April 2021, I had a virtual interview with members of Senator Leahy's staff, and on April 22, 2021, I had a telephone interview with Senator Leahy. On May 3, 2021, I interviewed with attorneys from the White House Counsel's Office. Since that date, I have been in contact with officials from the Office of Legal Policy at the Department of Justice. On August 5, 2021, the President announced his intent to nominate me.
