Dear Chairman Durbin and Ranking Member Grassley:

I have seldomly recommended nominees for judiciary appointments, as doing so entails a great responsibility and a deep understanding of the importance of the bench and the expectations we have from a judge's behavior and ethics nowadays. However, I unreservedly and enthusiastically support the appointment of Hon. Gina R.
