N/A. I have not addressed many of the questions in this section because I am not a lawyer.

That said, I have spent my entire career - more than 30 years - in government, philanthropy, and nonprofit organizations focused on community safety and improving the criminal justice system. My first internship with the criminal justice system was at the end of high school, and all through college I volunteered with justice-involved juveniles in probation, halfway house and school settings. My first job out of college was as a VISTA Volunteer at the Vermont Department of Corrections, developing reentry programs for people leaving prison.

I then spent two years managing a community service program for court-involved youth before going back to graduate school. At the Harvard Kennedy School of Government, I had an opportunity to work with David Kennedy and others at the very outset of the Boston Gun Project, which evolved into Operation Ceasefire (also referred to as focused deterrence/pulling levers) which has been widely influential as an effective, evidence-based strategy. I also engaged with the Lowell Police Department, focused on analysis and strategies to reduce assaults and violence.

After receiving my MPP, I worked at the National Institute of Justice (NIJ) as a Presidential Management Intern, developing community crime-reduction and reentry initiatives. I helped shape and manage the country's first national prisoner reentry efforts, the Strategic Approaches to Community Safety Initiative (SACSI), Community Mapping, Planning and Analysis for Safety Strategies Initiative (COMPASS), and the Crime Policy for the 21st Century Initiative. After three years, I left with then-NIJ Director Jeremy Travis to join the Urban Institute, where I spent 10 years directing projects focused on prisoner reentry and public safety. Through foundational Reentry Roundtables and seminal reports, I was part of the small team to define and establish reentry as a national concern, paving the way for federal reentry initiatives in the executive branch and the Second Chance Act of 2007.

I then spent seven years in the Obama-Biden Administration, serving as director of policy and senior advisor at the Office of Justice Programs (OJP), focused on

criminal justice reform, urban policy, and building trust between the justice system and communities of color. I concurrently served as executive director of the Federal Interagency Reentry Council, a cabinet-level body responsible for spearheading the federal Ban the Box rule (since codified by Congress as the Fair Chance to Compete for Jobs Act), fair housing guidance, the Second Chance Pell initiative, and Medicaid guidance for the justice-involved population.

Before returning to the Department of Justice (DOJ) in 2021, I spent almost four years as Vice President of Criminal Justice at Arnold Ventures, where I launched portfolios on corrections reform and expanding economic opportunity for justice-impacted populations. And in May 2021, I was appointed Principal Deputy Assistant Attorney General for OJP, DOJ's principal funding, research and statistical component, overseeing about \$5 billion annually in grants and other resources to support state, local and tribal criminal and juvenile justice activities and victim service programs. In my year plus at OJP, I have focused on being a good steward of federal dollars; raising morale and bolstering the dedicated career staff; leveraging our resources to best help jurisdictions keep their communities safe; and investing in science to inform practice and policy.

In sum, I have spent my career helping shape innovative approaches to criminal justice challenges in nonpartisan, bi-partisan, and evidence-based ways. I have strong ties and a history of collaboration with policymakers – on both sides of the aisle – as well as practitioners, funders, nonprofit leaders, and the advocacy community.
