Re: Nomination of Michael A. Delaney to the United States Court of Appeals for the First Circuit

Dear Senators Durbin and Graham:

We write as a group of trial attorneys who frequently represent as plaintiffs various victims of sexual and violent crimes in civil litigation matters, and we write particularly in response to the confirmation hearings recently held to consider First Circuit Judicial nominee Michael Delaney. Notably absent from the confirmation hearings was any meaningful discussion of Michael's nearly 30-year professional career, both as a public servant and a private practice trial attorney. We all know Michael well. We know from our experience working with and against him in various civil matters that he is not only an excellent advocate on behalf of his clients, but also a highly ethical and compassionate attorney. He represents his clients with utmost skill and with empathy toward all litigants, including the opposing parties. Additionally, many of us have witnessed firsthand Michael's specific efforts to protect the victims of sexual and violent crimes when he served as New Hampshire's Attorney General.

At Michael's confirmation hearing, we understand that questions were raised about his advocacy for a school client in one very challenging case. As practicing lawyers, we understand the duty Michael had as an advocate in that case to represent his client to the best of his abilities. And having known Michael for a long time, some of us working either with him or adverse to him in many sensitive cases throughout his nearly thirty year legal career, we know that he is a trusted, compassionate and ethical lawyer who will advocate for the best interests of his client, but above
