Dear Senators Schumer, McConnell, Durbin and Grassley:

We the undersigned crime survivors and victim/survivor service professionals offer our strong support for Steve Dettelbach to be confirmed as Director of the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF).

As a career prosecutor, Mr. Dettelbach has a stellar history of combatting violent crime, partnering with communities on effective crime prevention and reentry programs, and promoting community safety. As the U.S. Attorney for the Northern District of Ohio, he led the Defending Childhood Initiative to protect children exposed to violence program from a public health, mental health and treatment perspective. He has served with distinction in four Administrations – two Democrat and two Republican – and has received many honors for his work as a career prosecutor.

Across his entire career, Mr. Dettelbach has led Federal, national and state efforts to fight domestic terrorism, violent extremism and violent crimes motivated by hate and bias, including cases brought against a white supremacist for trying to burn down a predominantly African American church; a man targeting Jewish and African American community leaders; a man prosecuted for arson against the largest Mosque in Northwest Ohio; and a case that was, at the time, the largest prosecution of hate crime acts of religious violence in the Amish community. He has also been a national leader in the fight against human trafficking, having personally prosecuted an unprecedented number of human trafficking cases in Ohio. His sensitivity to the needs of hate crime survivors is evidenced by his selection by the Anti-Defamation League to represent victims of hate crimes in court proceedings in an ADL pilot program.

Mr. Dettelbach is proud that ATF has a strong victim/witness program that provides support and services to crime survivors across the Nation, particularly in cases involving mass violence and terrorism. His support for this important program will go far to ensure that *the entire Bureau* treats victims and survivors with dignity, and provides them the assistance they need and deserve.

Mr. Dettelbach's strong support from many law enforcement and prosecution professionals, including the Major County Sheriffs of America and the Federal Law Enforcement Association, is testament to the strength of this nomination.
