Re: WSAJ Support for Tiffany Cartwright's Judicial Appointment to the U.S. District Court for the Western District of Washington

Dear Chair Dick Durbin and Ranking Member Chuck Grassley:

The Washington State Association for Justice (WSAJ) writes in strong support of Tiffany Cartwright for appointment to the U.S. District Court for the Western District of Washington. WSAJ's mission is to protect and defend individuals' Constitutional right to have their day in court and to ensure that access to justice is not impeded by an imbalance of power or resources. Our members strive to ensure that real people have a voice and representation in the courtroom and that our laws are applied fairly and protect people from harm. We fight to ensure that access to justice is available for everyone. These are key values in the judiciary, and we are certain that Ms. Cartwright would uphold these values.

You are undoubtedly aware of Tiffany Cartwright's excellent qualifications; however, some of her experience is worth highlighting. She has dedicated her career to seeking justice for those who have been historically underrepresented. Her practice focuses on civil rights and representing workers who have been the victim of unlawful conduct in the workplace. She has gained incredible experience on cases involving police misconduct, gender discrimination and sexual harassment. These types of cases are particularly important because there is a power imbalance between victim and the wrongdoer. They are cases that require compassion, diligence, dedication, and persistence.

Ms. Cartwright is an experienced trial attorney. She has tried numerous cases in both state and federal courts and appeared twice before the Washington State Supreme Court. She has secured verdicts in several cases involving serious police misconduct—cases that are extremely challenging to win. It would be difficult to find a candidate who is more well-suited to joining our federal court in Western Washington. Senator Patty Murray said it best in her statement supporting Tiffany Cartwright for this judicial seat:
